### **Payments Through Your Bank's Bill Pay Service**

Payments through your bank's Bill Pay service should be made at least 14 Days Prior to the Nov. 15, 2024 due date to avoid late charges.

VISA DISCOVER Credit/Debit Card payments are accepted in the Tax Office through LexisNexis.

If you wish to pay in person with your Debit Card, make sure the amount you intend to pay does not exceed any daily limit imposed by your bank.

For card payments in the Tax Office, LexisNexis, the service provider, charges a fee of \$2.50 for debit cards & 2.35%, \$2.50 min., for credit cards

Check & cash payments are accepted in our office, but to avoid waiting in line, you can also drop off your check in our Tax Payment Dropbox located next to the front entrance of Courthouse Square at 555 Court St NE in Salem. (No cash in the Dropbox.)
