This matter came before the Marion County Board of Commissioners, acting as the Marion County Contract Review Board (Board), on at its regularly scheduled public meeting on Wednesday, September 13, 2017.

WHEREAS, the board finds that Marion County Business Services Department seeks an exemption from Marion County Public Contracting Rules, pursuant to Section 20-285, which provides for the use of alternative contracting methods as may be directed by the Board of Commissioners under ORS 279B.085; and

WHEREAS, Section 20-285 allows the Board to direct the use of alternative contracting methods as an exception to the prescribed public contracting practices in Oregon and its use must be justified in accordance with public contracting code and Marion County Public Contracting Rules; and

WHEREAS, Business Services completed an Informal Request for Proposal in 2015, awarding a contract to Idea Learning Group, LLC, to outsource the creation of the county's e-learning modules; and

WHEREAS, increased desire and cost effectiveness of e-learnings county-wide, interest has significantly increased to build specific e-learning modules for various departments; and

WHEREAS, as demonstrated in the Findings, attached as Exhibit A, contracting Idea Learning Group, LLC will allow successful continuation of e-Learning modules for the county, will not encourage favoritism, will not substantially diminish competition, and is reasonably expected to result in a cost/time savings for the County and promotes the public interest in a manner not practically realized by complying with the County's public procurement rules; and

IT IS HEREBY ORDERED that the Board adopts the findings attached hereto as Exhibit A and grants a Special Procurement exemption to allow the use of a contracts for services to provide custom instructional design and production services known as e-learnings beginning October 1, 2017 through June 30, 2022.

MARION COUNTY FINDINGS FOR EXEMPTION FROM CONTRACT REVIEW BOARD RULES FOR CUSTOM INSTRUCTIONAL DESIGN AND PRODUCTION SERVICES

Marion County Business Services Department (the Department) is requesting an exemption to allow the use of a special procurement to establish a long term county wide contract with Idea Learning Group to provide custom instructional design and production services known as elearnings for Marion County.

Background

In 2015, the Department completed an Informal Request for Proposal (IRFP) to obtain a vendor to outsource the creation of the county's e-learning. The contract was awarded to Idea Learning Group. In that time period Idea Learning Group has created approximately 30 e-learnings for Marion County. With the increased desire and cost effectiveness of e-learnings county-wide, interest has significantly increased to build specific e-learning modules for various departments. Idea Learning Group provides consistent, high quality products with exceptional customer service. The original not to exceed amount of the contract was reached within two years of the execution date. The contract has been amended twice to add additional funding exceeding the 20% threshold to complete the projects assigned due to the demand. The needs of the county departments to outsource the creation of quality e-learning has prompted a request for a long term, high dollar, county-wide contract with Idea Learning Group.

The contract with Idea Learning Group will expire June 30, 2018 and there is a need to continue contracting with this contractor to maintain consistency of e-learning modules and allow county departments to begin or finish their ongoing e-learning projects.

Findings

Idea Learning Group creates custom instructional design and production e-learnings in a product (Articulate Presenter and Storyline) that allows minor changes to be made by the county departments versus having to go back to the contractor for small changes in the final product (links, names, form changes, etc). Upon completion, the county departments own the source materials and are housed on the county's Learning Management System for county-wide e-learning accessibility. These editing and ownership processes are often not allowed by the e-learning vender community, thus saving the County time and money.

The District Attorney's Office has an immediate need to spend grant money by the end of the 2017 calendar year on multiple e-learning training.

The Finance Department has updated the PCard policy and would like to use the e-learning modules to provide its three different levels of PCard training every two years to employees who use the PCard program.

The Health and the Business Services departments began creating e-learning modules and would like to create additional, as well as update existing modules.

Through the initial IRFP, Idea Learning Group provided the County with a discounted non-government rate with volume discount. 30-minute sessions will cost \$12,000 whereas other companies based out of Oregon charge anywhere from \$13,300 to \$51,000. Thus resulting in a substantial cost savings to the County.

Idea Learning Group is certified with the Oregon Certification Office for Economic and Business Equity encouraging the use of a small business in Oregon.

Recommendation

The Business Services Department recommends approval of a special procurement for the award of a contract with a value not to exceed \$500,000.00 with Idea Learning Group for services to include custom instructional design and production of e-learnings with a term through June 30, 2022. The term and value of the contract are based on anticipation of additional county departments needs to maintain consistency.
