TITLE	Consider initiating zone code amendments to adopt revised floodplains maps for the area near Turner					
Issue, Description & Background	After the flooding Turner experienced in January 2012, the city requested a re-evaluation of the floodplain maps in the city and nearby. The city worked with a consultant to develop a new study of the floodplain and Marion County staff has been participating in the remapping process.					
	The study applies new, more accurate topographic information. As a result of the study, the floodway and floodplain will widen in some locations and narrow in others, and base flood elevations will generally increase. Marion County must adopt the revised maps provided by FEMA and regulate development to the new maps in order for the county and its citizens to be able to continue participating in the National Flood Insurance Program. The revised maps go into effect on October 18, 2019.					
	On May 20, 2019, Planning staff attended a Management Update meeting to discuss the revised maps with the board. Now staff is recommending the board initiate amendments to the Marion County urban and rural zone codes to consider adopting the revised maps.
