### **INFORMATIONAL**

#### **Aumsville Shops Relocation**

Summary of Presentation:

- Looking at replacing the current Aumsville shop;
- Looking to purchase the former Allied Waste property which is in downtown Aumsville;
- There are a lot of advantages to purchasing the property:
  - The land is 50 percent bigger than the current property;
  - The garage is in excellent condition;
  - More bays in the secondary building;
  - The property works well with the Continuity of Operations Plan (COOP);
  - The listing price is \$785,000; and
  - It's a safer location.
- The city of Aumsville is interested in the current property for their operations; and
- Public Works has enough money in their budget to make an offer.

#### **Conversion of a Stabilization and Crisis Unit (SACU) home in Marion County to a non-SACU Facility** *Summary of presentation:*

- SACU homes were created when Fairview closed to house the physically and mentally disabled;
- SACU is run by the Department of Human Services;
- Operates 23 residential group homes in the state, eight of them in Marion County;
- Of the eight homes in Marion County, two of them are children's homes;
- The manager of SACU contacted the county with an interest in talking about converting one of the current homes to a non-state facility;
- SACU currently employs 609 full time employees with a \$100,000,000 budget;
- Currently serves 108 individuals:
  - o 15 have highly specialized medical needs;
  - 83 adults; and
  - **10 youth**.
- Adults and youths enter the facility because their behavior is challenging to the point that a private provider in the system cannot manage their current needs;
- Marion County would like to recruit a provider to move into the home;

- American Federation of State and County Municipal Employees (AFSCME) submitted a public records request:
  - Requested what the county's conversations have been around converting the home from state run to privately owned; and
  - $\circ$   $\;$  What the impact is for individuals.
- The role of the county will be identifying new and appropriate levels of care; and
- The home will be privately owned.

## Marion County Developmental Disabilities Supports and Services Fair

Summary of presentation:

- A Save the Date flyer was given to all for the fourth annual Marion County Supports and Services Fair;
- The event will be at the Keizer Civic Center for families and providers to interact with each other; and
- The date is April 14, 2015.

## Male Advocates for Responsible Sexuality (MARS) Behind Bars

Summary of presentation:

- The program focuses on young men, teaching them responsible attitudes about how to behave and create positive relationship skills;
- Conducted within the Juvenile Department;
- Looking at a grant working with Benton County and Oregon State University to re-implement the program within the Juvenile Department;
- There are six sessions in the program;
- The grant deadline is March 5, 2015; and
- Will move forward with the grant application.

The Board would like to review the curriculum before moving forward with implementing the program.
