Issue, Description & Background	The Mid-Willamette Valley Cable Regulatory Commission (CRC) is an advisory committee formed by Marion County and the City of Salem through an intergovernmental agreement. The CRC is comprised of two city councilors and one county commissioner, and is staffed by county employees. The Marion County Board of Commissioners has the authority to appoint CRC staff.  With the recent retirement of Marion County Public Works Director Alan Haley, staff responsibilities of the CRC have been transferred from Public Works to the Finance Department and the CRC Cable Officer position is now vacant. Chief Financial Officer Jeff White has been identified as a qualified staff member to serve as the CRC Cable Officer.
