service clubs and other organizations. I have a strong interest in the betterment of the lives and services available to its residents. My dream is to in some way help make this happen. I also believe as an American citizen I have a duty to work toward the improvement of my community, if I am able.

The personal and professional interests that prompted me to apply for this appointment are:

I attended Serra Catholic High School in Salem and Lewis and Clark College in Portland, both of these schools gave me an ethic of service and trying to make a difference. I live on a 28 acre farm in Marion County and have always had an interest in my community. I have been a member of St. Mary's Parish , Shaw for 40 years and am a devout Catholic.
