TITLE Approve an order establishing a \$30 annual parking pass to park at North Fork, Bear Creek and Salmon Falls parks.

Issue, Description & Background Due to increased use of Marion County parks on the North Fork Corridor, the board of commissioners passed an ordinance delegating authority to the Director of Public Works to establish a parking fee on North Fork Road and an order establishing a parking fee of \$5 per car per day at North Fork, Salmon Falls, and Bear Creek parks, on May 11, 2016. County parks on the North Fork Corridor will open for the season on May 1, 2017, and we are proposing the board additionally approve a \$30 annual parking pass in North Fork, Salmon Falls, and Bear Creek parks, to better serve more frequent park visitors. In addition to this order, the Director of Public Works intends to adopt a \$30 annual parking pass in designated parking areas on North Fork Road, pursuant to the authority delegated to the Director of Public Works in Marion County Code section 10.08.010.

Financial Impacts: The annual parking pass will generate funds needed to assist with the maintenance of the parking areas. Actual attendance in the parks has not been tracked, so the actual impact to the parks fund is to be determined.

Impacts to Department & External Agencies The Sheriff's Office will be impacted due to enforcement needs around non-payment of the fee or pass.

Options for Consideration: 1. Approve the order establishing a \$30 annual parking pass for North Fork, Bear Creek and Salmon Falls parks. 2. Direct staff to make changes to the order. 3. Do not take any action at this time.

Recommendation: Staff recommends the board of commissioners approve the order establishing a \$30 annual parking pass for North Fork, Bear Creek and Salmon Falls parks.
