Issue, Description & Background
The Marion County Board of Commissioners formed the Marion County Parks Commission by order on September 16, 1958. The parks commission consists of seven voting members who serve four-year terms appointed by the board of commissioners. Currently, there is one vacant position.

The county received an application for the parks commission from Mr. Faulkner, and he was interviewed by the parks commission chair and staff on October 29, 2018. The consensus was to recommend him for appointment to the parks commission by the board of commissioners.

Mr. Faulkner lives in Keizer and works as a superintendent and general contractor for Hoffman Construction. He has worked in the construction industry for over 20 years and was the project superintendent on the Portland Japanese Garden.
