Issue, Description & Background		This request is from an individual property owner that the county concur in an amendment to the City of Gervais urban growth boundary for 0.53 acres, which, once annexed would permit an additional 2-3 homes on the property.  The property owner made an application to the City of Gervais last year and the city approved the request on July 5, 2018. Now the property owner has made an application to the county to concur in the amendment. In order to expedite the county process, planning recommends the board approve an order initiating consideration of the amendment, calling up the land use request and scheduling a hearing on the matter.

ORDER	

IT APPEARING, that the City of Gervais Comprehensive Plan and Urban Growth Boundary was adopted as part of the Marion County Comprehensive Plan on February 28, 1979, by Ordinance No. 530; and

IT APPEARING, that the City of Gervais has approved an ordinance for an Urban Growth Boundary amendment for residential land; and

IT APPEARING, that the January 25, 2006, Urban Growth Boundary Coordination Agreement between the city and county requires that both jurisdictions adopt amendments to their respective comprehensive plans applying to portions of the urban growth area outside the city limits; and

IT APPEARING, that Oregon Revised Statutes 215.050 authorizes the county governing body to revise the County Comprehensive Plan; and

IT APPEARING, that the Marion County Comprehensive Plan requires plan amendments be initiated by the Board of Commissioners; and

IT APPEARING, that the county has received an application from the property owner requesting a legislative amendment to the county's comprehensive plan to concur in the city's urban growth boundary amendment, Legislative Amendment Case #19-001; and

IT FURTHER APPEARING that Marion County Code section 17.110.765 provides that the Board of Commissioners may assume original jurisdiction over a land use application; and if jurisdiction is assumed by the Board, the length of the decision making process and staff effort can be reduced significantly and commencement of development can be expedited; now therefore.

IT IS ORDERED that the Marion County Board of Commissioners hereby initiates consideration of amendments to the Marion County Comprehensive Plan related to the City of Gervais urban growth boundary; and

IT IS FURTHER ORDERED that the above-referenced application is hereby called up for consideration by the Marion County Board of Commissioners pursuant to Marion County Code section 17.110.765; and

IT IS FURTHER ORDERED that the Board hereby schedules a public hearing to receive testimony on the proposed amendment for 9:30 a.m., Wednesday, March 20 2019, at the Senator Hearing Room, 1<sup>st</sup> floor, Courthouse Square Building, 555 Court Street NE, Salem.
