Issue, Description & Background The planning division has received an application for a small mass gathering permit to take place July 21-22, 2018; July 28-29, 2018; August 11-12, 2018; and August 18-19, 2018, and for annual renewal for the years 2019, 2020, 2021, and 2022, on an 80.55 acre parcel in an EFU (Exclusive Farm Use) zone located at 6518 Cascade Highway NE, Silverton. Section 9.25.050 of the Marion County Code allows the board of commissioners to grant a permit for a mass gathering only after review at a public hearing.

WHEREAS, on May 2, 2018, Whitewind Woodland LLC, applied for a small mass gathering permit to take place July 21-22, 2018; July 28-29, 2018; August 11-12, 2018; and August 18-19, 2018, and for annual renewal for the years 2019, 2020, 2021, and 2022, on an 80.55 acre parcel in an EFU (Exclusive Farm Use) zone located at 6518 Cascade Highway NE, Silverton (T6S; R1W; Section 25; tax lot 900); now therefore,
