Subject: Chemeketa SOAR _ Amendment #1

The Marion County Sheriff's Office (MCSO) contracts with Chemeketa to provide staff in support of the employment and education component of the (Student Opportunity for Achieving Results) SOAR Program. The contract with Chemeketa that became effective on July 1, 2017 was originally created for \$192,361.00 for the first year of the biennium. The availability of additional funds is dependent on the Criminal Justice Commission Justice Reinvestment Initiative Grant Agreement that was Awarded in January, 2018 and a review of expenditures spent in the first year of the biennium.

As an exception, the Sheriff's Office would like to amend this IGA to add \$190,919.00 for year 2 of the biennium, exceeding 20% of the original contract amount. All services provided under this IGA will remain the same through June 30, 2019.

AMENDMENT #1 to the
INTERGOVERNMENTAL AGREEMENT
between

MARION COUNTY and CHEMEKETA COMMUNITY COLLEGE

The Intergovernmental Agreement, entered into pursuant to ORS Chapter 190, as may be amended from time to time, the “Agreement,” between Marion County “County”, a political subdivision of the State of Oregon, and Chemeketa Community College, “College”, dated July 1, 2017.

The Agreement is hereby amended as follows (new language is indicated by underlining and deleted language is indicated by brackets):

2. PURPOSE/STATEMENT OF WORK

The purpose of this Agreement is to establish the terms and conditions under which the College will provide SOAR (Student Opportunity for Achieving Results) Program services to County. These services are further described in Section 5.

3. TERM AND TERMINATION

3.1 This Agreement shall be effective for the period of July 1, 2017 through June 30, 2019 [JULY 1, 2017 through JUNE 30, 2018] unless sooner terminated or extended as provided herein.

4. FUNDING AND BILLING

4.1 The total amount paid under this contract shall not exceed \$383,280.00 [\$192,361.00]. Payments under this contract shall be made on actual costs incurred.

Except as expressly amended above, all other terms and conditions of the original Agreement are still in full force and effect. The Parties certify that the representations, warranties and certifications contained in the original Agreement are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.
