TITLE Distribution of Oregon State Forestry timber revenue as per ORS Chapter 530

Issue, Description & Background ORS 530.115 provides for the distribution of revenues generated by timber sales from certain lands located within the county. Pursuant to the statute, the state has distributed \$469,650.94 to the county for the fourth quarter of 2017-2018. The county must now also distribute the monies in accordance with the statute. The treasurer has applied the distribution formula and prepared a list of the entitled entities and the appropriate amounts to be distributed. The distribution list and a form of board order are attached.
