

## Community Resource Network

### TERMS OF AGREEMENT

#### A. General

- 1. The Community Resource Network (CRN) connects resources to people by putting organizations in touch with each other in order to share information that will either promote the physical, educational or mental development of children or youth or to provide for the basic needs of children, youth or families.
- 2. Members are permitted to use CRN to share extra resources for the benefit of children, youth or families, to seek help with unmet needs of children, youth or families, or to develop community-wide service-oriented events that will benefit children, youth or families.

#### B. Membership

- 1. Members must be one the following entities:
  - i. A public body in the State of Oregon (ORS 174.109 defines "public body" as state government bodies, local government bodies and special government bodies. "Special government bodies" include school districts, education service districts, community college districts, intergovernmental bodies, and entities created by statute/ordinance);
  - ii. A private non-profit corporation registered in the State of Oregon that serves or benefits children, families or youth in Marion County;
  - iii. A private for-profit entity that is registered to do business in the State of Oregon.
- 2. Members must not discriminate on account of race, color, religion, sex, sexual orientation, national origin, marital status or age in violation of Oregon or federal law.
- 3. Membership is subject to approval by the Marion County Children and Families Department Director who has complete discretion to deny or terminate membership at any time.

#### C. Protocols

- 1. Before submitting a request on CRN, members agree to first check the 211 system to see if the needed service or resource is available in the local area. If the 211 system cannot meet the need, then CRN may be considered for appropriate requests.
- 2. All requests and posts must be intended and used to benefit children, youth or families in Marion County, Oregon.
- 3. Requests may not be used or intended to meet the general operational needs of an organization. CRN requests may not to be used by a member to supplement that member's operating budget.
- 4. CRN requests may not be used as a promotional tool for a member or to advertise, promote or market a member's customary programs.
- 5. CRN requests and posts may not include or disclose individual identifying information, confidential information, or information that is otherwise protected by law.
- 6. CRN may not be used for any illegal activity, pecuniary gain or commercial purpose.
- 7. CRN may not be used to discriminate in violation of Oregon or federal law.
- 8. The Marion County Children and Families Director has complete discretion to decline to post any request or to remove any request from CRN at any time.
