Review and Discussion Committee Applicant:

 - From Stayton
 - Owner of the Covered Bridge Café in Stayton
 - Does a lot of Mentoring for incarcerated Women that want to be reconnected with their children
 - Serves on the Sheriffs Office Advisory board
 - Active member Chamber of Commerce
 - Serves on the Police Safety Commission

Review and Discussion:

- Enhanced Detox
 - Recruiting for the key positions
 - Expect to start serving people in June
 - There is a required quarterly learning collaborative between the statewide detox providers, Bridgeway, Marion County, AMH, and DMAP
 - Support is around how to sustain the new services.
 - The difference between mentors and case managers.
 - Bridgeway secured a medication machine called pixel
 - There is a Matrix of the target outcomes of the new program.

 - New preventive services happening each year
 - Annual Alcohol screening
 - Annual Depression Screening
 - This is a model similar to what the CCO's are doing for brief solution focused care

 - There are two subcommittees
 - Public Health – currently focused on the health assessment and community health improvement plan
 - Behavioral Health – currently focused on recruitment

Marion County Parole and Probation:

- Invitation to share about new program.
 - Hawaii and Washington have implemented a new program that has immediate consequences for person violating there parole and probation. Oregon is looking at adopting a similar program
 - If there is a missed appointment or failed drug test they are put in jail for 1-30 days.
 - Sue will do some research and bring back information to the next meeting.
