Call to Order: Chair Ray Wilson called the meeting to order at 8:06 a.m.

Announcements:

- Tim Murphy – Bridgeway obtained grant with Marion County sheriffs' office.
Monies used for transitional housing program for men and women being released
from prison.

Approval of Meeting Minutes:

- No minutes for review from October meeting as group toured Woodmansee.

- **Presentation:**
 - **Medication Assisted Treatment:**
 - There are 110 more individuals in treatment this year.
 - 365 individuals enrolled in treatment receiving Methadone; 80 of those are under age 30. There has been an average of 12 intakes per month.
 - There are requirements to participate in program with emphasis on treatment, which is expected.

- Program is longer than most treatment programs as treatment is most successful for individuals that participate for at least 2 years.
 - Short term programs are available; 21 days (medical withdraw), 6 months, however, short term is discouraged.
- Cost for program is approximately \$8400 for 2 years, which includes doctor visits, medication, counseling and mentor services
- Individuals must meet specific criteria to enter program. An assessment is completed and other options are considered first, along with physician input.
- Methadone dosage set by prescribing physician.

Presentation:

➤ **Heroin Increase; Pill Usage Down:**

- Since mid 90's overdoses on Opiates have tripled.
 - Methadone is a valid and valued treatment for Opiate addiction.
 - Heroin use has doubled in the past two years.
 - Heroin use up due to cost of pill rising.
- Medicated assisted treatment is a valuable tool for treatment and recovery.

- Group discussed value of filling open spot with a liaison from parole/probation as held traditionally in the past, or open up for a community member.
