<u>Law Enforcement Assisted Diversion (LEADS) Presentation: (handout)</u> Josh Lair; Marion County:

Program helps break down barriers with law enforcement and law enforcement is more widely trained in this area. There has been willingness to engage with clients and try new approaches.

People committing sex crimes or violent crimes are not eligible for program.

LEADS is a grant funded program and is currently recruiting for 2 additional LEAD navigators who provide intensive case management and connect individuals with needed resources. Josh also assists individuals with shelter or housing, basic needs, the court system and other goals.

Currently 23 individuals in program; of those 16 actively checking in on a regular basis, of those 11 are engaged in A & D treatment, 3 are in residential services and 2 have completed housing program and are housed.

Every referral to program has been homeless to date.

Program focused on highest crime areas in Salem.

Individuals arrested are given seven days to contact Josh and enroll in program. If they enroll, their arrest is labeled as a "no action case". If they fail to enroll, they may be prosecuted.

<u>Update: Status of Mid-Valley Opioid Safety Group Grant (handout)</u>

Sub committee met on 12/4

Venue - The Keizer Community Center has been secured for Friday and Saturday, September 27^{th} and 28^{th} .

Catering – Ray talked to Cari regarding catering. She needs to know what the budget is first. Name of conference: Opiates and Pregnancy; Neonatal Opiate Withdrawal Syndrome and Beyond.

Committee discussed conference format – Keynote speakers on day one and two with break-out sessions following with a wrap up on day two with a Q & A session.
