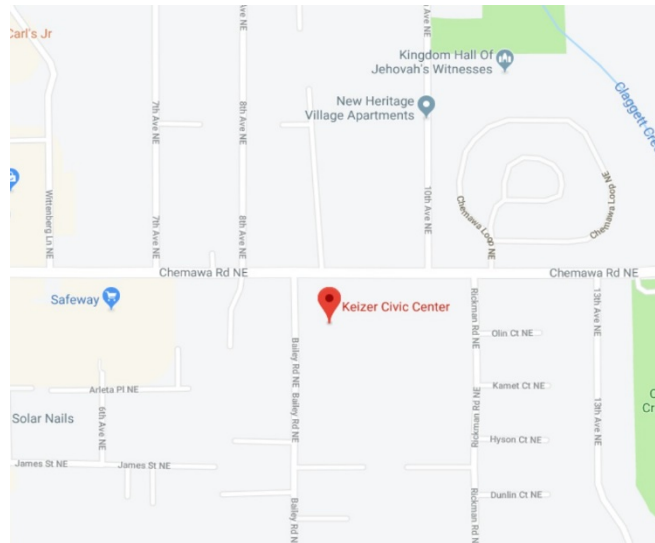

# Keynote Speaker: Barbara Cimaglio

Barbara Cimaglio is a nationally recognized leader in the field of alcohol and drug abuse prevention, treatment, and recovery. Her career spans over 40 years of service at the state and local level. In 2004, she became the Deputy Commissioner for Alcohol and Drug Abuse programs at the Vermont Department of Health (VDH) where she helped develop model programs to address the opioid crisis. Prior to joining VDH, Ms. Cimaglio directed the Office of Alcohol and Drug Abuse Programs for the State of Oregon (1997-2004) and held the position of Director of the Department of Alcoholism and Substance Abuse for the State of Illinois from 1994-1997. She began her state service with the Illinois Department of Alcoholism and Substance Abuse in 1988 as a Prevention Manager and subsequently directed the Prevention Division prior to assuming the directorship of the Department.

Ms. Cimaglio has been instrumental in the development of alcohol and drug abuse systems of care at the state level. She is currently on the Board of the National Association of State Alcohol & Drug Abuse Directors, and has been a leader in that organization since her time in Illinois. As a founding member of the Illinois Substance Abuse Counselor Certification Board, Ms. Cimaglio helped develop one of the first state credentials recognizing counselors in this field. She began her own career as a counselor and program director for Youth Outreach Services, an agency serving adolescents and families in the city of Chicago.

Ms. Cimaglio received a Bachelor's of Arts degree in psychology from the University of Illinois and studied at the graduate level at Governor's State University in Illinois. She is now semi-retired and currently an independent consultant and addictions program professional.

# Conference Overview

Neonatal Opioid Withdrawal Syndrome (NOWS) is a postnatal drug withdrawal syndrome in newborns caused primarily by in utero exposure to opioids. The United States has seen a threefold increase in the incidence of NOWS during 2000-2012. During the same time, Oregon has seen a fivefold increase. In 2016, the nation had an average opioid-related hospital stays of 296.9 per 100,000; Oregon's average is 388.7 per 100,000.

Oregon is top in the nation for opiate problems and the state is mobilizing to develop effective programs to address the opiate epidemic head on, and reduce incidence of overdose, NOWS, and SUD.

When community resources, medical and social services, housing, the court system etc. can coordinate and develop local programs to help affected families, everyone benefits individuals, families, and communities.
