I, _____,		)	Defendant, being duly sworn deposed and say:

1. I hereby apply for participation in the Traffic Safety Diversion Program.
2. I have no convictions or diversion for any motor vehicle violation (including DUII) within the three years immediately preceding the date of this citation.
3. I do not have a Commercial Drivers License.
4. I have no other pending motor vehicle citations in this or any other court.
5. There was not an accident associated with the alleged offense.
6. The Traffic Violation is not a Class A Violation or a No Insurance Citation.
7. This is not a Mobile Electronic Device violation.
8. I agree to plead no contest to the traffic offense with which I am currently charged.
9. I agree to pay the non-refundable presumptive fine for the offense with which I have been charged and the traffic school fee.
9. Payment must be received before the end of the 7<sup>th</sup> day from the first court appearance. The presumptive fine is \$\_\_\_\_\_.
10. I agree to attend and complete the court mandated traffic course and provide proof of completion within 90 days.
11. I agree that I will not receive a citation for a motor vehicle violation within the next 180 days.
12. I understand that if I comply with the conditions of my diversion, the Court will officially close this case.
13. I understand that if I do not comply with the conditions of my diversion, the diversion will be terminated and I will be convicted of the offense. I also understand there will be NO extensions, NO exceptions.
14. I will keep the court advised of my current mailing address and telephone number during the 180 days diversion period.
