_____)	Defendant, being duly sworn deposed and say:

1. I hereby apply for participation in the Traffic Safety Educational Diversion Program.
2. I do not have a Commercial Drivers License.
3. I agree to plead no contest to the traffic offenses with which I am currently charged.
4. There was not an accident associated with the alleged offense.
5. The Traffic Violation is not a Class A Violation or a No Insurance Citation.
6. I agree and understand that I will be convicted of the first offense and this charge will be reported to the Oregon Department of Motor Vehicles (DMV) to be recorded on my driving record.
7. I agree to pay the non-refundable presumptive fines for the offenses and the traffic school fee.
8. I agree to pay the full amount of the first offense and (1/2) half of the presumptive fine for the charge which is marked (educational diversion).
9. Payment must be received before the end of the 14th day from the first court appearance. The presumptive fine is/are

10. I agree to attend and complete the court mandated traffic educational course and provide proof of completion within 90 days.
11. I understand that if I comply with the conditions of my educational diversion, the court will officially close the above mentioned violation which has been marked (educational diversion).
12. I understand that if I do not comply with the conditions of my educational diversion, the diversion will be terminated and I will be convicted of the offense. I also understand there will be NO extensions, NO exceptions.
13. I will keep the court advised of my current mailing address and telephone number during the 90 days during the diversion period.

15. The court does not approve online courses for the educational diversion.
