1. By Mail

2. Bill-Pay Service*

- ◆ **Your six-digit Property Tax Account Number**
- ◆ **The amount you would like to pay**

*Be sure to *schedule* your payment at least **14 Days Prior** to the **Nov. 17, 2025** due date to avoid late charges.

Paystation, the service provider, charges a fee of 3% for credit/debit cards and \$1.70 for electronic checks.

- ◆ Debit/Credit Card**
- ◆ Drop Off: You can drop off your check in our dropbox located next to the entrance to our building. *(No cash payments in the dropbox)*
