1. Consider approval of a resolution authorizing property tax exemptions of up to \$250,000 assessed value of a homestead to surviving spouses of fallen public safety officers in Marion County, pursuant to Senate Bill 1513. – Commissioner Janet Carlson

Summary of presentation:

- Senate Bill 1513 (2016) allows counties to approve a resolution or an ordinance to authorize a tax exemption;
- A public hearing was held on November 30, 2016;
- This resolution includes an exemption for surviving spouses of:
 - o Fire Service professionals;
 - o Police Officers; and
 - Reserve Officers.
- All jurisdictions in Marion County would be included; and
- The fiscal impact would not be significant for jurisdictions being affected.

MOTION: Commissioner Carlson moved for approval of a resolution authorizing property tax exemptions of up to \$250,000 assessed value of a homestead to surviving spouses of fallen public safety officers in Marion County, pursuant to Senate Bill 1513. 2. Consider approval of the Purchase Order with CDW-G to provide Nimble Storage hard drives, support premium extended service agreement, expansion shelves and four hour parts delivery support for \$316,812 through December 31, 2017. - Tom Frey

Summary of presentation:

• Replaces aging enterprise storage systems:

- o Increases capacity performance and features;
- o Replaces aging storage connectivity; and
- o Replaces aging back-up and recovery systems.
- Nearing capacity on enterprise storage, supported on over 250 servers;
- Primary back-up and recovery systems are at capacity;
- This product is on the state price agreement;
- Information Technology staff has been reviewing this product for a long time and feel that this solution is the best fit based on Marion County requirements;
- Highly recommended for its ease of use and vendor upgrades;
- The product will increase performance on storage response by six-fold:
 - o Reduces infrastructure complexity and long term maintenance costs;
 - o All-inclusive software licensing product;
 - o Flat annual maintenance support fee; and
 - o Enhances back-up and recovery capabilities.

Board discussion:

- Once the agreement is signed, implementation will be two weeks and a 45-day window to review the product will take place:
 - Will likely be in production by the beginning of February.

3. Consider adoption of an administrative ordinance granting Legislative Amendment (LA) 16-002, regarding amendments to the Marion County Code, Title 16 (Urban Zone Code) and Title 17 (Rural Zone Code) by emergency procedure. – Joe Fennimore

Summary of presentation:

- Board initiated the amendments by resolution in March 2016;
- The purpose of the amendment is to adopt provisions to regulate medical marijuana businesses;
- The matter was referred to the planning commission, which held a public hearing in August 2016;
- The planning commission issued a recommendation to the board on the type of regulations that should be applied to marijuana businesses;
- The board held a public hearing on November 30, 2016:
 - The amendments were approved and staff was directed to prepare the appropriate ordinance for consideration.
- The ordinance is set for emergency procedure;
- The county adopted a moratorium on marijuana businesses:
 - o Referred it to the voters;

- o Recreational business measure failed so the ban stays in place; and
- o Medical marijuana business measure passed, allowing medical marijuana businesses in Marion County.
- Amendments include:
 - o Allowed to grow medical marijuana in farm use zone land;
 - o Required to grow marijuana indoors;
 - \circ Visible grow lights to be turned off between the hours of 7:00 p.m. 7:00 a.m.;
 - Other grow sites are permitted in industrial zones with a conditional use permit;
 - All processing will take place in industrial zones with a conditional use permit;
 and
 - O Dispensaries will only be allowed in a commercial zone, with a conditional use permit.

MOTION: Commissioner Carlson moved that the chair read the ordinance by title only twice.
