Summary of presentation:

- The grant brings funding in for Marion County Parks;
- The agreement with the Oregon Parks and Recreation Department (OPRD) is part of the Local Government Grant Program;
- Funding will be utilized for projects at Parkdale Park:
 - The park is located in the East Salem Service District (ESSD) on Hayesville Drive.
- The grant requires a 50 percent match:
 - o The county will utilize American Rescue Plan Act (ARPA) funding for the match.
- No county funds will be used for the project;
- Park amenities will include the following:
 - o Walking paths;
 - o Improved parking;
 - o Picnic tables;
 - o Barbecues;

- o Lighting; and
- o A playground.
- The grant has a stipulation that requires Parkdale Park to remain a park for 25 years;
- There are no impacts to the county;
- A Federal Land and Water Grant was used when the county initially acquired the park:
 - o The initial grant required the park to remain a park in perpetuity.
- Staff recommended the grant for \$355,823 be approved.

Board discussion:

- Construction will begin in late spring when the land is drier;
- Staff anticipate the park will open in the summer with the new amenities; and
- There should be no traffic impact on Hayesville Drive during the construction phase.
