Summary of presentation:

• Inclement weather prevented the appointees from attending the meeting in person.

Board discussion:

- There is one vacancy that still needs to be filled;
- Individuals interested in volunteering for the Marion County Fair are encouraged to apply;
- The Marion County Fair Board meets on the first Wednesday of every month;
- The month prior to the fair is a very busy time and there is much work to be done; and
- The county's Intergovernmental Agreement (IGA) with the state for the fairgrounds expires in 2027:
 - o The state has new policies that may impact the IGA; and
 - o The state changes will be discussed at a later date.

6. Consider approval of the Purchase Order with Waxie Sanitary Supply in the amount of \$150,000 to provide janitorial supplies, industrial paper products, and custodial equipment for Marion County buildings through June 30, 2024. –Terry Stoner

Summary of presentation:

- The county's current contract with Waxie Sanitary Supply is for custodial supplies and small equipment;
- The current contract is for \$100,000;
- The request is to increase the Purchase Order up to \$150,000;
- This increase will be utilized for the purchase of equipment for the new Marion County Health and Human Services (MCHHS) building;
- The county received three bids for the supplies and equipment;
- Waxie Sanitary Supply submitted the lowest bid; and
- Staff are requesting approval of the Purchase Order.

Board discussion:

- Contract review board is not needed as the amendment amount is small; and
- There was a management update meeting regarding this request.

Motion: Commissioner Bethell moved to approve the Purchase Order with Waxie Sanitary Supply in the amount of \$150,000 to provide janitorial supplies, industrial paper products, and custodial equipment for Marion County buildings through June 30, 2024. Seconded by Commissioner Willis; motion carried. A voice vote was unanimous.

Board discussion:

- Commissioner Bethell expressed the following:
 - o County departments do a great job communicating information to the public;
 - O There is a lot happening behind the scenes that the public does not see when there is inclement weather:
 - Public Works staff works extensive hours to prepare roads for upcoming inclement weather; and
 - The Marion County Sheriff's Office (MCSO) responds to emergencies that are a direct result of the weather.
 - O Departments that provide 24-hour services regardless of the weather include:
 - The Marion County Sheriff's Office;
 - The Marion County Jail;
 - The Marion County Juvenile Department;
 - Marion County Health and Human Services including:
 - The psychiatric crisis center;
 - Horizon House; and
 - The Medication Assisted Treatment (MAT) program team.
 - Marion County Business Services:
 - The facilities team are continually ensuring that parking areas are safe for staff that provide 24-hour services.
- Commissioner Cameron thanked the citizens that stayed home and kept themselves and their families safe;
- Commissioner Bethell shared her experiences from her recent trip to Washington D.C. where some of the following was discussed:
 - o The opioid and homelessness crisis;
 - The work Marion County is performing to address the issues; and
 - o Funding challenges that counties face.
- Commissioner Willis discussed a recent article in a local publication that expressed the following:
 - O The State of Oregon spends twice as much per person on treating mental illness but is in the bottom five nationwide for positives outcomes;
 - O The article argued that this is because the state is not in control of everything, but this is not true;
 - Oregon has not done a good job of handling the Oregon State Hospital;
 - o Individuals that claim to be experts do not know what is occurring in local communities:
 - This author does not understand the treatment process and how the work gets done; and

- There is not an understanding of how the process works for an individual on the street, living with an addiction, that transitions to a safe place and receives treatment.
- Commissioner Bethell expressed a federal government representative feels counties will be the entities to find resolution for the opioid epidemic:
 - They are aware that local level authority is witnessing every day the negative impacts of the crisis;
 - o A partnership between counties and cities is needed to solve the crisis;
 - The state needs to provide adequate resources in an equitable manner, because every community is different including:
 - Populations;
 - Cultures; and
 - Geographies.
 - o Federal funding should go directly to the counties and not the state; and
 - O Counties are able to distribute the funding to communities faster than the state.
