# **Review 2021 Marion County Fair Mask Policy and Procedures**

### Summary of presentation:

- In consultation with Legal Counsel, there have been conversations regarding direction given to staff and volunteers at the fair on how to enforce mask usage;
- Anticipating using Center for Disease Control guidelines as direction for mask usage at the fair;
- Will post signs at entry gates:
  - Doors to buildings.
- Looking for board direction.

 The commissioners are not wanting fair staff to enforce people to wear masks that are not vaccinated.

# Discuss the Private Sale Process of the Family Burial Grounds Cemetery in Sublimity

- Jeff White, Camber Schlag
  - It is a large piece of property with a small burial ground in the corner;
  - The lot is currently being farmed;
  - Two of the surrounding property owners put in an offer that matched the minimum bid; and
  - Needing board approval to sell the property.

# Discuss Local Funding Priorities for the Emergency Rental Assistance Program

- Lisa Trauernicht

### Summary of presentation:

- Looking for board direction if they would like to add priority preference requirements for individuals;
- Required prioritization is at 50 percent median income;
- Another required priority is one or more people being unemployed more than 90 days within the household;
- There are two different funding streams for emergency rental assistance:
  - The first set of funding states the applicant has to be directly affected by the pandemic; and
  - The second set of funding states the applicant did not pay their rent during the pandemic timeframe.
- Cannot apply if above 80 percent median income;
- The funding priorities are for the algorithm for the software company;
- Commissioner Willis was interested in reaching out to LEAD:
  - o If an individual was referred to an agency, that can be a priority.
- Preference priorities for the board are as follows:
  - o Fire;
  - Seniors;
  - Families:
    - Adult with child/children.
  - o Referrals from Marion County programs.
- The Marion County Housing Authority is eligible to apply for this program.

## Ice Storm/Beachie Creek/COVID-19 Update

### Summary of presentation:

### Brian Nicholas:

- Property cleanup numbers on the website that The Oregon Department of Transportation (ODOT) are reporting are the same as last week:
  - o There are 45 percent of the properties that are cleaned up; and
  - o ODOT has sent closure letters to 72 property owners.
- Will be sending out a letter regarding rights of entry forms:
  - Will be putting hard copies at SIT in Sublimity and Gates City Hall;
  - ODOT's deadline will be June 30, 2021:
    - There is an online portal option to sign up as well.
- Submitted the Ice Storm public assistance application to FEMA last week.

### Tamra Goettsch:

- There are three hotels being used for displaced wildfire victims:
  - o 28 rooms; and
  - o 47 people.
- The state is working on transitioning people from hotels into interim housing;
- There are 13 families that have moved from SIT to Community Action Agency:
  - Families were not in stable housing before the fire.

### LEGISLATIVE UPDATE:

### Summary of presentation:

- Senate Bill 464 Wildfire Property Tax Relief:
  - Dash 4 Amendments:
    - Needed to define Disruption of Use:
      - If something happened between September 1-30, 2020, and a property owner was unable to access their property due to road closures:
        - Water service;
        - Sanitation service;
        - Electricity; or
        - Telecommunications.
      - Highway 22 was closed until October 12;
      - · Detroit was without water for months; and
      - The definitions will allow the county to draw their wildfire boundary and disruption of use boundary.
    - Once the bill passes, it will be effective after September 27, 2021.
- House Bill 3127 Wildfire Funding:
  - o In Rep. Clem's committee on Friday; and
  - Passed out of committee.
- Friday was the deadline to get bills out of policy committees.

#### Kevin Cameron:

- The pastor from Gates Community Church would like to purchase the trailer that the county has parked on their property:
  - Would like to use it as a construction trailer.
