PROCLAMATION

COMMUNITY SERVICES - Action

1. Consider approval of a proclamation designating the month of April 2024 as Child Abuse Prevention Month in Marion County. – Sarah Coutley; Kyle Tarr, Liberty House; Vanessa Nordyke, Court Appointed Special Advocates (CASA) of Marion County; and Tanya Hamilton, Family Building Blocks

Summary of presentation:

Tanya Hamilton, Family Building Blocks:

- Family Building Blocks has been serving the community for over 25 years;
- The organization's mission entails:
 - o Keeping children safe;
 - o Keeping families together; and
 - o Preventing child abuse in communities.
- Multiple organizations are part of the Marion County Child Abuse Prevention Month Committee:
 - o Child abuse prevention is year-round.
- Child abuse neglect numbers for 2022 include:
 - o An estimated 41.6 percent of the victims were five years old or younger;
 - o Eighty percent of a child's brain is developed by the age of three:

- Ninety percent of development occurs by the age of five.
- o There were 10,711 victims of child abuse and neglect in Oregon; and
- o There were 1,098 victims of child abuse and neglect in Marion County.
- It is important to recognize child abuse early so that children can grow and thrive; and
- Blue ribbons have been placed on a tree in Riverfront Park:
 - o The ribbons represent confirmed victims of child abuse and neglect in communities.

Vanessa Nordyke, Court Appointed Special Advocates (CASA) of Marion County:

- CASA advocates for all children in foster care in Marion County;
- CASA collaborates with the following for child safety:
 - o The Marion County Sheriff's Office; and
 - o The Marion County District Attorney's Office.
- Adults play an important role in preventing child abuse including:
 - o Parents;
 - o Family members;
 - o Caregivers;
 - o Friends;
 - o Teachers;
 - o Coaches:
 - Mentors: and
 - o Faith leaders.
- Adults can educate youth on the following:
 - o The world around them;
 - o Body safety;
 - o Healthy boundaries;
 - Healthy touch; and
 - How to identify safe adults.
- Individuals are encouraged to seek training to recognize and react responsibly to concerns of child abuse:
- Youth need healthy and positive relationships in their lives;
- Prevention becomes effective when individuals become aware and then act accordingly;
 and
- Everyone can be a positive role model and help in different ways including:
 - o Training staff around you;
 - o Reporting suspected abuse or neglect;
 - o Being empathetic;
 - o Being available to youth; and
 - o Knowing your neighbors.

Kyle Tarr, Liberty House:

• It is important to acknowledge and honor daily prevention activities;

- Building healthy relationships with youth is important;
- Community activities and displays for Child Abuse Prevention Month are available on the county's website;
- Individuals are encouraged to get involved and support local organizations that strengthen families;
- The 2024 theme for Child Abuse Prevention Month is "Paint the Town Blue":
 - o Events and activities occurring during the month of April include:
 - Wearing blue to show support;
 - A car parade will be held;
 - Blue light will be displayed on the Union Street Bridge;
 - Blue light will be displayed on the City of Woodburn bridge;
 - A pinwheel window display:
 - Pinwheels are the national symbol of hope.
 - A tree at Riverfront Park will be decorated with blue ribbons; and
 - A ribbon cutting will be held at Liberty House in the City of Woodburn.
- Everyone plays a role in preventing abuse and keeping children safe;
- Liberty House will be providing free training in both English and Spanish throughout the month of April; and
- Individuals are encouraged to contact the Oregon Child Abuse Hotline if they suspect child abuse is occurring.

- Marion County buildings will be lit up blue;
- Commissioner Willis expressed that individuals that have suffered abuse as a child, no matter how long ago, are important and what they suffered does not define who they are, and he is grateful for their presence and service in our community.
- Commissioner Bethell expressed the following:
 - o This work is taken seriously, and services are being expanded in the county;
 - o Individuals should not have to leave their communities to seek help; and
 - o Programs are available for individuals that need help.
- Commissioner Cameron expressed the following:
 - o This work is a team effort;
 - When abuse cases make it to the Marion County District Attorney's Office, then efforts have failed:
 - We can continue to recover from this failure.
 - Changing the location of the tree annually will show that the issue is a statewide and countywide issue; and
 - There are many kids and parents that need help and support.

MOTION: Commissioner Bethell moved to approve a proclamation designating the month of April 2024 as Child Abuse Prevention Month in Marion County. Seconded by Commissioner Willis; motion carried. A voice vote was unanimous.

Summary of presentation:

- Amendment #1 to the Intergovernmental Agreement (IGA) with the Mid-Willamette Valley Council of Governments (MWVCOG) increases funding that will be utilized for a contractor payment account;
- In 2023, the cap amount increased from \$15,000 to \$50,000;

- Amendment #1 will allow contractors to be paid in a timely and expedited manner;
- The contractor payment account has a maximum funding amount of \$200,000:
 - This allows for four projects at the maximum amount of \$50,000 each;
 - o The account cannot drop below \$50,000 until the funds are depleted; and
 - The county will maintain control over the majority of the funds.
- Once funds are deposited into the MWVCOG account then the county may request a reimbursement from the United States Department of Housing and Urban Development (HUD):
 - o This also allows the county's funds to be replenished in a timely manner.

• Amendment #1 to the contract was discussed in detail at a prior meeting.

MOTION: Commissioner Bethell moved to approve Amendment #1 to the Intergovernmental Agreement with Mid-Willamette Valley Council of Governments (MWVCOG) to add \$1,412,445 for a new contract total of \$1,889,147 for management of the Marion County, Homeowner Residential Rehabilitation Program for low-to-moderate income residents through May 30, 2027. Seconded by Commissioner Willis; motion carried. A voice vote was unanimous.

6. Consider approval of the Contract for Services with Riverbend Materials in the amount of \$330,400 for the purchase and delivery of chip seal aggregate for the 2024 Marion County Chip Seal Program through December 31, 2024.

Summary of presentation:

- The contract with Riverbend Materials is for the purchase and delivery of chip seal aggregate;
- The pavement preservation process involves spraying liquid asphalt on a road's surface and then covering the material with a layer of aggregate;
- The contract with Riverbend Materials is for a one-year term;
- Chip seal treatments provide a durable and waterproof wear course;
- The treatment process can extend the life of the existing pavement;
- Approximately 57 miles of roadway will be treated with chip seal over the 2024 summer months:
 - It is anticipated that the work will start in July and be completed by the Labor Day holiday.
- The locations and schedules of the road work can be found on the county's website:
 - Outreach is also provided through social media; and

- Message boards will be displayed prior to chip seal applications.
- During the chip seal process only one traffic lane will be open;
- Motorist are encouraged to exercise caution when travelling through work zones;
- The Contract for Services with Riverbend Materials is for \$330,400;
- The contract was awarded through an Invitation to Bid process; and
- The 2024 Chip Seal Program is a budgeted expenditure.

- The county will be performing extensive repairs on some roadways that involves milling in the wheel paths:
 - o Repairs on these roadways may be performed over a two-year period; and
 - o A double chip seal process may be performed that utilizes special aggregate.

Motion: Commissioner Willis moved to approve the Contract for Services with Riverbend Materials in the amount of \$330,400 for the purchase and delivery of chip seal aggregate for the 2024 Marion County Chip Seal Program through December 31, 2024. Seconded by Commissioner Bethell; motion carried. A voice vote was unanimous.

7. Consider an appeal of the hearings officer's decision for Administrative Review (AR) Case #23-033/Bodunov. –Nicole Inman

Summary of presentation:

- The item before the board is to consider an appeal of the hearings officer's decision for Administrative Review (AR) Case #23-033/Bodunov;
- The applicants applied for an Administrative Review (AR) to determine the number of legal lots on 26.65 acres of land:
 - o The property is located on Abiqua Road NE in a Timber Conservation (TC) zone.
- The hearings officer held a duly noticed public hearing for the application on January 4, 2024;
- On February 8, 2024, the hearings officer issued a decision determining that the property constitutes one legal parcel;
- The hearings officer's decision was appealed on February 22, 2024;
- The appeal was discussed at a board session meeting on March 20, 2024:
 - The board tabled the item until March 27, 2024, for further review.
- On March 20, 2024, staff recommended denying the appeal:
 - Staff received new information after the March 20,2024, board session meeting;
 and
 - o Staff are now requesting that the board consider accepting the appeal.
- The applicants disagree with how the hearings officer drew from applicable laws; and
- There may be a policy interpretation for the board to consider.

- Commissioner Willis expressed the following:
 - o There is a decision that the board can make with the policy on an interpretation of the law from the boards perspective;
 - He would like to accept the appeal; and
 - He would like the opportunity to discuss this.
- Commissioner Bethell expressed that she supports Commissioner Willis' request;
- Commissioner Cameron expressed he would like the applicants to have the opportunity to be heard and explain what may be possible;
- The applicants have granted an extension that would allow the board time to consider the request;
- A decision by the board is needed by August 8, 2024; and
- Staff will coordinate a future meeting date with the applicant.

MOTION: Commissioner Bethell moved to approve an appeal of the hearings officer's decision for Administrative Review (AR) Case #23-033/Bodunov. Seconded by Commissioner Willis; motion carried. A voice vote was unanimous.
