Recognizing Sheriff Jason Myers and his 30 years of service to Marion County. – Commissioner Kevin Cameron and Undersheriff Troy Clausen Marion County Undersheriff Troy Clausen:

- Undersheriff Clausen wishes to recognize Sheriff Jason Myers for his 30 years of service to the community, and present him with the Sheriff's Office Meritorious Service Award;
- It is a rare honor to be presented with this award; The award recognizes Sheriff Myers for his unwavering commitment and service to all through professional application of leadership principles;
- During his career Sheriff Myers has remained focused on the following:
 - Behavioral health:

- Providing an efficient, fair, an equitable system for individuals experiencing a behavioral health crisis;
- He has joined with local experts to streamline processes and divert individuals in crisis away from jail and into a community based treatment program; and
- The success of Sheriff Myers' efforts in behavioral health is now being replicated in other counties and states across the nation.

- He holds an Executive Police Certificate from the Oregon Department of Public Safety and Standards;
- His career with Marion County started in 1989, at the age of eighteen, when he was hired by the Sheriff's Department to work as a summer park cadet;
- He joined the Marion County Reserves Deputy Program and was hired as a full time deputy in September of 1990;
- Sheriff Myers has held the following positions:
 - o Parole Deputy;
 - o Field Training Deputy;
 - o Judicial Security Deputy;
 - School Resource Officer;
 - o Detective:
 - o Patrol Sergeant;
 - o Narcotics Detective Sergeant;
 - o Administrative Lieutenant;
 - o Operations Division Commander;
 - o Undersheriff; and
 - o Sheriff.
- Sheriff Myers has also spent time lobbying at the state capitol for issues that are important to Oregon;
- Some of his responsibilities included the following:
 - o Developing policies and procedures;
 - o Crafting strategic plans;
 - o Negotiating union contracts;
 - o Preparing and managing the office budget; and

Marion County Health and Human Services Health Advisory Board (HAB) 2019 year end summary. —Cary Moller, Patrick Vance, and Michael Mann

Summary of presentation:

Cary Moller:

- The county is statutorily required to have a HAB;
- The HAB board, a citizen volunteer board, advises the board of commissioners and the Health and Human Services Administrator on important matters related to the health of our community;
- The HAB has two formal subcommittees:
 - o The Intellectual and Developmental Disabilities (IDD) Council; and
 - The Local Alcohol and Drug Planning Committee.
- The board represents some of the following:
 - o Families and individuals in service;
 - o Public safety;
 - o Education;
 - o Social services; and
 - o Health care community partners.

Patrick Vance:

- Mr. Vance is the current chair of the HAB;
- The board members have expertise in some of the following areas:
 - o Medicine:
 - o Education; and
 - o Social services.
- The HAB board focuses on the representation of Marion County citizens and the issues that impact the social structure and their lives.

Lieutenant Treven Upkes:

- Lieutenant Upkes is a member of the City of Salem Police Department and a HAB member:
- Law enforcement officers are on the streets and in the communities working to get individuals with mental health issues the services that can improve their lives and their quality of living;
- Lieutenant Upkes' career as a police officer allows him to bring the knowledge and information he has gained in his job experiences back to the HAB.

Deborah Patterson:

- Ms. Patterson is a HAB member and a representative of the Intellectual and Developmental Disabilities Advisory Committee (IDDAC);
- The IDDAC has a variety of representation that includes some of the following:
 - o Parents of children and young adults with IDD;
 - o Providers of services;

- Advocacy groups;
- o Teachers; and
- o Former case managers.
- The IDDAC recently completed a strategic plan which seeks to address the following needs:
 - o An increased community awareness of services that are provided;
 - o An increased and more responsive community and partner engagement; and
 - o Increasing the number of providers for the following:
 - Child care;
 - Adult foster homes:
 - 24-hour residential care;
 - Employment providers;
 - Personal support workers; and
 - Transportation providers.
- The IDDAC will continue to review, analyze, and identify continuing quality improvement opportunities; and
- Ensure compliance with state and federal regulations.

Sean Moriarty:

- Mr. Moriarty is a HAB member and an employee with Youth ERA;
- Mr. Moriarty is able to provide the HAB with input from the perspective of a young adult that he has encountered in his career; and
- He is able to take the information he has gained as a HAB member, and communicate and work with the young adults and community members he encounters with Youth ERA.

Michael Mann:

- Mr. Mann is a mental health advocate and a HAB member;
- Engaging with the community has been an important goal for the HAB:
 - o It provides information about what is working within the community; and
 - o It provides insight into the communities' needs that the HAB may be able to assist with.
- Methods of communication that the HAB has used to engage the community include the following:
 - o Social media: and
 - o A movie related to trauma informed care has been released.

John Lattimer:

- Marion County Sheriff Jason Myers is scheduled to retire on June 30, 2019;
- Commander Joe Kast from the Marion County Sheriff's Department has been selected for the appointment of Marion County Sheriff with an effective date of July 1, 2019; and
- Adoption of a board order is required before the appointment can be executed.

Joe Kast:

- Commander Kast states he is both honored and privileged to have been selected for the position of Marion County Sheriff;
- Commander Kast has worked as a deputy with Sheriff Myers for several years; and
- He is looking forward to continuing to build on the foundation that the Sheriff's Office has been working on for many years.

Board discussion:

- The county has gone through a selective and competitive process to fill the sheriff's position;
- It was a unanimous decision by the board to appoint Commander Kast to the office of Marion County Sheriff;
- Today's board order will be the formal appointment;
- Commander Kast will occupy the position until the next general election;
- Commander Kast is committed to run for the office of Marion County Sheriff in the next general election; and
- Marion County citizens will make the final decision at that time for the sheriff's position.

Summary of presentation:

- The county has an agreement with the City of Woodburn that entails the Woodburn Police Department providing mobile crisis services to the Woodburn community; and
- The Woodburn Police Department will provide after-hours support and follow-up services through June 30, 2021.

Board discussion:

- There are currently three teams providing this support in the following locations:
 - o The Marion County Sheriff's Office;
 - The City of Woodburn Police Department; and
 - The City of Salem Police Department:
 - A fourth team is being prepared that will also be based out of the City of Salem Police Department.

- One team goal is to help prevent individuals from going to jail by getting them into services that are more appropriate for the events that are currently happening in their lives;
 - o The services are more cost effective;
 - o There is less trauma to the individuals; and
 - o There is less trauma to the families.
- Mobile crisis services are provided throughout the county seven days a week:
 - o Services are provided from 8:00 a.m. through 2:00 a.m.; and
 - o This team will provide services four days a week for ten hours per day.

MOTION: Commissioner Willis moved to approve an Intergovernmental Agreement with the City of Woodburn, on behalf of the Woodburn Police Department, in the amount of \$300,000 to provide after-hours support and follow up for the Mobile Crisis Response Team through June 30, 2021. Seconded by Commissioner Brentano; motion carried. A voice vote was unanimous.

3. Consider an order approving the Sole-Source Procurement for the renewal of Tyler Technologies, Inc. software application and licenses. –Scott Emry and Camber Schlag *Summary of presentation:*

- The Information Technology (IT) Department and the Assessor's Office are requesting an exemption for the annual renewal of a software license and maintenance support fees for the county's assessment and taxation software;
- On June 14, 2019, a notice of the county's intent was posted on the Oregon Procurement Information Network website:
 - o The notice was posted for seven days; and
 - o No comments or protests were received.
- The annual renewal is necessary for the continuation of the software application and will include the following:
 - o The software license;
 - o Upgrades;
 - o Maintenance;
 - o Patches; and
 - o Technical support if needed.
- The county has been using the software since 2007;
- The renewal will allow for efficient utilization of existing services;
- The continued purchase of the license is unlikely to diminish competition from public contractors;

- The IT Department and the Assessor's Office are working with a vendor for a replacement system through a cooperative contract;
- The renewal will be for the fiscal year 2019-20; and
- The software will cost \$185,712.14.

Board discussion:

- The Finance Department is asking for approval of an order for a special procurement; and
- If approved, the Finance Department will ask for approval of a contract with the next agenda item.

4. Consider approval of the Annual License and Services Agreement with Tyler Technologies, Inc. for assessment and taxation software used by the Assessor's Office for \$185,712.14 through June 30, 2020. —Scott Emry and Camber Schlag

Summary of presentation:

- Mr. Emry stated the software was purchased in 1997, not 2007 as originally stated;
- The Marion County Assessor's Office uses the software to process assessments and taxation;
- The software system retains data related to some of the following:
 - o Ownership of properties;
 - o Lot sizes;
 - o Sales activities;
 - o Inventory on all improvements to land; and
 - o Special assessment information.
- The software system is also to calculate some of the following until the tax roll is certified:
 - o Tax rates;
 - o Urban renewals; and
 - o Joint values with other counties.
- The agreement plays an important annual role for the county, especially in relation to general funds;
- The Information Technology (IT) Department is requesting renewal of the software application for one year that will end on June 30, 2020; and
- The IT Department is pursuing potential replacements for this software.

Board discussion:

- Mr. Lattimer expressed his displeasure over the services the county has received from Tyler Technologies, Inc.;
- The county will be replacing the out-dated software as soon as a substitution is found:
 - o It could potentially take 14-24 months before the software is replaced; and
 - The IT Department may need to come before the board of commissioners at a later date to complete the transition.

MOTION: Commissioner Willis moved to approve the Annual License and Services Agreement with Tyler Technologies, Inc. for assessment and taxation software used by the Assessor's Office for \$185,712.14 through June 30, 2020. A. Public hearing to consider the application to transfer the franchise for Ambulance Service Area (ASA) #5 to the new ownership of Woodburn Ambulance Services, Inc. –Cary Moller, Shawn Baird, and Erin Miller

Summary of presentation:

Cary Moller:

- Metro-West Ambulance Inc. has purchased Woodburn Ambulance Services Inc.:
 - The ambulance service will continue to operate under the name of Woodburn Ambulance Services Inc.
- Emergency and non-emergency ambulance services in the county are regulated by county code and state law:
- Currently there are ten franchise ambulance service areas within the county;
- Each ambulance service area is assigned to one of the ambulance providers.
- Emergency medical response working in conjunction with hospital emergency departments can involve the following:
 - o Citizens;
 - o Dispatchers;
 - o Law enforcement;
 - o Firefighters;
 - o First responders;
 - o Emergency medical technicians; and
 - o Paramedics.

- The ambulance service collaborative and coordinated efforts are directed by the Marion County Area Services Plan;
- The Ambulance Service Area Advisory Committee routinely meets to consider matters relevant to the ASA:
 - They also review the ASA Plan in order to make recommendations to the administrator and the board of commissioners.
- Residents and visitors of Marion County benefit from an established ambulance service system and public safety professionals;
- On June 12, 2019, the board of commissioners received the application to transfer the franchise for Ambulance Service Area (ASA) #5 to the new ownership of Woodburn Ambulance Services, Inc.;
- Ms. Moller found no issues of concern related to the transfer; and
- She recommends approval for the transfer.

Support:

Shawn Baird:

- Mr. Baird has over 29 years of experience providing medical services to citizens in North Marion County;
- In 1994 he became a co-owner of Woodburn Ambulance Service, Inc.;
- Mr. Baird's business partners are anticipating retirement and wish to successfully transition the business over to a new partner who can provide the following:
 - o Quality care for the citizens; and
 - o An opportunity for Mr. Baird to continue his career in Marion County and in Woodburn.
- Woodburn Ambulance Service, Inc. and Metro West Ambulance Inc. have collaborated through the years on different issues to ensure both companies are continually advancing their quality of care; and
- The two companies have assisted each other when the need arose.

Erin Miller:
