This matter came before the Marion County Board of Commissioners at its regularly scheduled public meeting on Wednesday, May 01, 2024, to consider the removal of a member of the Mental Health Advisory Committee and the appointment of a member to the Mental Health Advisory Committee.

WHEREAS, the Board of Commissioners has established the Mental Health Advisory Committee in accordance with ORS 430.630; and

WHEREAS, the Marion County Mental Health Advisory Committee serves as the structured advisory group to the Local Mental Health Authority, and serves the public interest by supporting the effective development and operation of the Marion County Health & Human Services (MCHHS) Community Mental Health Program (CMHP); and

WHEREAS, there is a vacant position as Nichole Miller is unable to meet the membership requirements and unable to complete her term as a member of the Mental Health Advisory Committee; and

WHEREAS IT APPEARING to the Board of Commissioners that Serenia Dotson is qualified and willing to serve for the remainder of the vacant position's term on the Mental Health Advisory Committee; now, therefore,

IT IS HEREBY ORDERED that Nichole Miller is removed as a member of the Marion County Mental Health Advisory Committee; and
