The purpose of the Marion County Mental Health Advisory Committee ("Committee") is to serve as a structured advisory group to the Marion County Local Mental Health Authority ("Local Mental Health Authority"). Its primary purpose will be to support the effective development and operation of the Marion County Health & Human Services (MCHHS) Community Mental Health Program (CMHP) through provision of key information, materials, and data informed recommendations to the Local Mental Health Authority.
