Requested Action: Approve a Board Order authorizing the expenditure of County Road Fund dollars for emergency maintenance activities on Milton Street NE, a Local Access Road.

Issue, Description & Background: Milton Street is a Local Access Road in unincorporated east Salem. The poor condition of the road impedes ready access to emergency service vehicles and warrants corrective action by Marion County Public Works. The proposed Order authorizes the expenditure of county funds for one-time maintenance activities to restore a driving surface.

Financial Impacts: The cost of this work falls within the Marion County Public Works Department's existing road maintenance budget.

Impacts to Department & External Agencies: The repair of Milton Street will improve neighborhood access for emergency response agencies.

This matter came before the Marion County Board of Commissioners at its regularly scheduled public meeting on Wednesday, March 19, 2025.

WHEREAS, Milton Street is a local access road located in the unincorporated area of Marion County; and

WHEREAS, ORS 368.031 authorizes a county governing body to expend county moneys on a local access road if it determines, among other reasons, that the work is an emergency; and

WHEREAS, Milton Street is in such a state of disrepair that it is difficult and dangerous for emergency vehicles to travel on Milton Street, thereby decreasing response time for the residents of Milton Street; and

WHEREAS, the condition of Milton Street described above makes county work on Milton Street an emergency; now, therefore,

IT IS HEREBY ORDERED that county work to improve Milton Street is an emergency, such that county moneys may be expended for a single surface maintenance project pursuant to ORS 368.031.
