Issue, Description & Background:	Planning Commission (PC) member Stanley Birch's term ended July 2, 2024, PC member Mike Long's term ended February 1, 2024 and PC member Gary Monders' term ended February 11, 2024. Mr. Birch, Mr. Long and Mr. Monders are interested in and are able to serve an additional term. Over the course of their service they have all gained valuable insight and knowledge of Marion County's land use process and have conducted themselves in a courteous manner to members of the public, county staff and fellow commissioners. Nick Harville and Daisy Goebel both have experience that allow them to provide strong service to the Marion County Planning Commission as well.
