Requested Action:	Approve order authorizing property tax refund for Herron Crossing LLC.
Issue, Description & Background:	Taxpayer appealed the value of account 327912 for the 2023 and 2024 tax years to Magistrate Division and the Assessor and Taxpayer stipulated to values that reduced the AV. ORS 311.806 (1) requires the county governing body to issue refunds in situations like this. The total amount of
	the refund due (plus statutory interest) is \$43,027.77. The Board has delegated authority to issue tax refunds under \$20,000 to the tax collector; all others must go to the Board for approval.
Financial Impacts:	The amount of the refund (with interest through 5/15/25) is \$43,027.77.
Impacts to Department & External Agencies:	None, beyond the processing of the refund itself.
