Requested Action:	Approve order authorizing property tax refund for OGSC Macys LLC
Issue, Description & Background:	Taxpayer appealed the value of account 589030 for the 2024 tax year to PVAB which lowered the AV for the account. ORS 311.806(1) requires the county governing body to issue refunds in situations like this. The total amount of the refund due (plus statutory interest) is \$29,953.29. The Board has delegated authority to issue tax refunds under \$20,000 to the tax collector; all others must go to the Board for approval.
Financial Impacts:	The amount of the refund (with interest through 5/15/25) is \$29,953.29.
Impacts to Department & External Agencies:	None, beyond the processing of the refund itself.
