Issue, Description & Background		ORS 530.115 provides for the distribution of revenues generated by timber sales from certain lands located within the county. Pursuant to the statute, the State has distributed \$15,701.87 to the county for the first quarter of 2020-2021. The county must now also distribute the monies in accordance with the statute. The Treasurer has applied the distribution formula and prepared a list of the entitled entities and the appropriate amounts to be distributed.
