This matter came before the Marion County Board of Commissioners at its regularly scheduled public meeting on Wednesday, June 24, 2026.

WHEREAS, the Marion County Public Works Environmental Services North Marion Recycling & Transfer Station has had an existing cash drawer of \$800.00 for several years; and,

WHEREAS, the North Marion Recycling & Transfer Station has identified the need to increase the change fund from \$800.00 to \$1,600.00 due to implementing a new operating system and updating their cash handling procedures to assign each scale attendant their own cash bag; and,

WHEREAS, the North Marion Recycling & Transfer Station has found the existing amount of change authorized in their cash drawer insufficient for their current need; and,

WHEREAS, the North Marion Recycling & Transfer Station has made provisions to assure control of the requested change fund and the Marion County Treasurer, and the Marion County Controller have reviewed and approved the proposed control measures in accordance with Marion County Administrative Policy 903; and,

WHEREAS, Marion County Administrative Policy 903 requires the approval of the County Administrative Officer and the Board of Commissioners to establish change funds; and,

WHEREAS, it appears in the best public interest to increase the change fund for the North Marion Recycling & Transfer Station; now, therefore,

1. IT IS HEREBY ORDERED that a change fund be increased for the Marion County Public Works Environmental Services North Marion Recycling & Transfer Station from \$800.00 to \$1,600.00.
