BUSINESS SERVICES

1. Consider ratification of Marion County Juvenile Employees Association Collective Bargaining Agreement for July 1, 2014, through June 30, 2016. – Amy Rose Fish, Faye Fagel

Summary of presentation:

- Requested board ratify Marion County Juvenile Employee Association (MCJEA) tentative agreement;
- Major changes to agreement:
 - o Article 8, Section 6 Bereavement Leave:

- Language incorporated stating an employee who qualifies for Oregon Family Leave Act (OFLA) will receive bereavement leave according to OFLA. An employee that does not qualify under state and/or federal protected leave laws will receive a maximum of five working days.
- o Article 10, Section 4 Employer Health Insurance Contributions:
 - Insurance cap \$1,346 per employee, per month; and
 - If cost of renewing plan exceeds five percent of employer contribution parties will reopen Article 10 for negotiations. Each party may also reopen one noneconomic language item.
- o Article 11, Section 3 Wage Adjustment:
 - Effective August 31, 2014, general pay range increase of 2.5 percent. Effective July 1, 2015, general pay range increase of 2 percent.
- Agreement affects 40 employees.

Board discussion:

- Board reviewed agreement at October 6, 2014, Management Update meeting; and
- Thanked Juvenile Director Faye Fagel/Business Services staff.

MOTION: Commissioner Cameron moved ratification of the Marion County Juvenile Employees Association Collective Bargaining Agreement for July 1, 2014, through June 30, 2016. Seconded by Commissioner Carlson; motion carried. A voice vote was unanimous.

 - o Mission is to immerse world in belief that every person in every community has the right to live in a world free of abuse and violence.
 - Recited Hands & Words Are Not For Hurting Pledge.

 - o October 2014, Domestic Violence Awareness Month in Marion County; and
 - o 2014 United Way fundraising campaign.
- Hands Project makes a difference in community; and
- Board noted the absence of Leslie Middle School Peer Helpers.

4. Consider second reading and adoption of an ordinance amending the Noise Code Provisions. – Joe Fennimore, Commander Kevin Schultz

Summary of presentation:

- Community notification of ordinance amending noise code provisions:
 - o Board of Commissioners:
 - Issued press releases on September 10 and 25, 2014.
 - o Sheriff's Office:
 - FlashAlert Newswire notification to Willamette Valley media/community/business subscribers;
 - Community Resource Unit notified public via social media; and
 - Subject business owner notified via telephone/written correspondence.
 - Public Works:
 - Constituent requesting consideration notified via written correspondence.

Board discussion:

- Verified Public Works received no negative feedback;
- Reviewed events leading up to ordinance amendment:
 - County received complaints about excessive noise from businesses within Salem-Keizer UGB, particularly music;
 - Marion County Code (MCC) Chapter 8.45 had exemption that exempted permitted commercial uses from noise code;
 - City of Salem's code did not have same provision. Board chose to amend MCC noise code to remove exemption for commercial properties inside Salem-Keizer UGB;
 - At public hearing, constituent asked board to consider similar change for properties outside Salem-Keizer UGB and board directed staff to develop ordinance for consideration;
 - o Proposed ordinance amends MCC 8.45.080(I) and removes exemption for sounds created or produced by specific devices such as radios, musical instruments, etc.;
 - Board approved/read ordinance amending MCC 8.45 noise code provisions by title once on September 17, 2014;
 - October 1, 2014, board directed staff to conduct more community outreach; and
 - Ordinance now to be read second time/becomes effective 90 days later.

MOTION: Commissioner Cameron moved to have the chair read the ordinance by title only once (reading for 2nd time). Seconded by Commissioner Carlson; motion carried. A voice vote was unanimous.

Chair read ordinance by title only once/second reading.

MOTION: Commissioner Cameron moved adoption of an ordinance amending the Noise Code Provisions. Seconded by Commissioner Carlson; motion carried. A voice mail was unanimous.

Board Session Presentation Notes October 15, 2014

I am Rich Minaker of the Finance Department.

I'm here to present the 1st Supplemental Budget request for the Marion County fiscal year 2014-15 budget. Oregon Revised Statutes requires that increases to appropriation authority from the original adopted budget must be adopted by the governing body. Public notice of this supplemental budget was published in the Statesman Journal newspaper in accordance with statutory requirements. The budget information is available on the Marion County website and at the Board's Office reception desk.

Details of the first supplemental budget were reviewed with the Board of Commissioners at Management Update on October 6. The first supplemental budget increases the total budget by \$495,417. During my discussion of budget all amounts will be stated to the nearest one thousand dollars.

The first supplemental budget is exclusively to approve appropriations for all departments to cover a 3% cost-of-living allowance (or COLA) pay increase in accordance with a collective bargaining agreement and further extended to exempt employees by the Board of Commissioners.

The **General Fund** total budget will remain unchanged, with no additional resources. Contingency is reduced by \$695,000. \$596,000 is allocated to personnel services of the eight departments that comprise General Fund departmental operations.

\$99,000 is allocated to Transfers Out to other funds to cover COLA costs as follows: \$30,000 to the Child Support Fund, \$1,000 to the County Fair Fund, \$17,000 to the Dog Control Fund, and \$36,000 to the Juvenile Grants Fund; these cover the full COLA cost; in addition, \$9,000 is transferred to the Central Services Fund to fund a portion of Board of Commissioner's Office cost, and \$5,000 is transferred to the District Attorney Grants Fund to also pay a portion of the cost.

The Central Services Fund budget will increase \$403,000, of which \$394,000 is Administrative Cost Recovery revenue and \$9,000 is the previously mentioned transfer from the General Fund.

To repeat the result of General Fund Transfers Out:

The Child Support Fund budget will increase \$30,000.

The County Fair Fund budget will increase \$1,000.

The Dog Control Fund budget will increase \$17,000.

The Juvenile Grants Fund budget will increase \$36,000.

The **District Attorney Grants Fund** budget will increase by \$5,000 due to the previously discussed increase in General Fund Transfer; reductions in Materials and Services and Contingency will fund the remaining \$10,000 needed to cover the \$15,000 total cost.

The County Clerk Fund has a \$2,000 reduction in Materials and Services to fund the COLA cost.

The Sheriff's Grant Fund has a \$2,000 increase in Net Working Capital to fund the COLA cost.

The COLA cost in all other funds has been funded by a reduction in Contingency. These amounts are:

Building Inspection Fund \$40,000
Community Corrections Fund \$77,000
Environmental Services Fund \$59,000
Health Fund \$777,000
Land Use Planning Fund \$17,000
Law Library Fund \$3,000
Parks Fund \$2,000
Public Works Fund \$314,000
Surveyor Fund \$10,000
Traffic Safety Team Fund \$3,000

Although the countywide cost of the COLA is \$2.4 million much of it is funded by shifting budget authority to Personnel Services from other expenditure categories. A shift between expenditure categories does not cause a fund budget to increase. The first supplemental total budget increase of \$495,000 is the result of a \$396,000 total increase in resources and \$99,000 in transfers between the General Fund and other funds.
