



City of Silverton Transitional Housing Standards



Periodic review and renewal for the proposed use

• If the transitional shelter obtains an initial approval by the Planning Commission, he first periodic review and renewal shall be conducted six months from occupancy and shall follow the conditional use review procedure. If renewal is approved, periodic review and renewal shall be conducted annually from that point, following the conditional use review

• Review actual operational evidence for the Planning Commission to consider, and if they do not find the use has been meeting the criteria, it could be

• Standards require the applicant to submit a security that would cover the costs of removal if the use is not renewed. This could take the form of a cash deposit sufficient enough for the applicant's to use to remove the sleeping
