Action Items

- 1. Transition Center to Jail Transition:
 - Transition process moving adults in custody to the jail was smooth.
 - Reduced number of people moved to 15 through alternative releasing.
 - Staff received extra training to ease them into their new environment.
 - Positive feedback from crew leaders on improved staffing and crew management post transition.
 - The jail has not reached its 470-bed capacity, with the female count remaining around 20-25.
 - Courts running reduces jail populations by transitioning individuals to prison.
- 2. Stabilization Center Update:
 - Plan to change the Transition Center to a Stabilization Center with 24/7 staffing.
 - Goal is to have a case management approach focused on rehabilitation and reintegration.
 - New staff roles like stabilization center specialists and counselors to replace deputies:
 - Staff will undergo a field training model specific to their roles, which will be different from traditional jail deputy training.
 - Exploring removing firearms from corrections academy to expedite hiring and certification.
 - Integrating comprehensive programming including substance abuse and mental health treatment.
 - Bridgeway has applied for a grant to provide staff at the stabilization center, focusing on addiction treatment.
 - Discussions around collaborating with Health Department to provide services.
 - The goal is to ensure that the stabilization center has the necessary resources and partnerships to provide comprehensive care.

- The program aims to provide additional mentors, cognitive behavioral classes, and other resources for individuals at the stabilization center.
- Reallocation of \$200,000 in Justice Reinvestment funds to expand the stabilization mentor program
- The goal is to ensure that the stabilization center has the necessary support to effectively rehabilitate and reintegrate individuals.
- 3. JRI Council:
 - Proposal to sunset the Justice Reinvestment Council as its functions are redundant
 - Potential to move oversight of Client Victim Services Support Fund to the Marion County Public Safety Coordinating Council.
 - Streamlining oversight and ensuring effective use of funds

Informational Items (Discussion/Possible Action)

- 1. HB 4002:
 - Use the stabilization center for referrals from the Law Enforcement Assisted Diversion (LEAD) program and other enforcement partners.
 - Exploring how to best integrate services and avoid duplication between the stabilization center and existing programs.

Other Business

- 1. New recruitment page and social media ads for the Sheriff's Office.
- 2. More inmates now available for work crews:
 - More inmates are able to receive their medications while working.
- 3. Emphasis on community engagement and funding.
- 4. Logistics around seating, table captains, and planning for Marion County Reentry Initiative event.

Future Agenda Items

- 1. Future Meeting Dates/Times:
 - Recommendation to schedule a recurring meeting, potentially quarterly, to discuss community corrections and public safety.
 - Need to determine appropriate committee or council to oversee the JRI funds and related programming.
 - By-laws for community corrections need to be adopted annually and that the chair rotation includes the sheriff and commissioner.
