Commissioner Danielle Bethell called the meeting to order at 1:33 p.m.

Bio Clean Franchise

- Citing Process:
 - o Bio Clean submitted franchise application for medical waste processing.
 - Verified \$250 fee and obtained conditional use permit.
 - Seeking solid waste permit from Marion County.
 - The facility capacity is 1200 tons annually.
 - Currently processing 600 tons from Marion County.
 - o Proposed ozone treatment method for medical waste decontamination.
- Marion County Franchise Process:
 - o Proposed 10-year franchise agreement with potential 5-year extension.
 - Franchise fee structure:
 - Zero fee for in-county waste.
 - Potential fee for out-of-county waste.
 - Types of medical waste to be processed:
 - Infectious waste (sharps, surgical tubing, medical garments).
 - Potential future expansion to pathological waste.
 - Monitoring and accountability measures to be included in franchise agreement.

Reworld Update

- Decommission Process:
 - Majority of staff is laid off.
 - o Potential sale to interested party (Joseph) failed.
 - Reasons for sale failure:
 - Disagreement over financial terms.
 - Liability concerns.

- Potential broader corporate strategy.
- Next Steps:
 - Explore legal action to ensure property returned to Exclusive Farm Use (EFU).
 - o Investigate condemning water rights.
 - o Potential interest in purchasing water rights or property.
 - o Confirm decommissioning and demolition timeline.

Discussion of Future Meetings

- Scheduled deep dive into cost process on June 26.
- Continued monitoring solid waste legislative issues.
- Review of Clayton Ward closure impact.
- Monitoring Senate Bill 1067 and 3794.

Next Steps

- Review water quality report for Covanta facility.
- Contact potential buyer about facility acquisition.
- Assess environmental and financial implications of property.
- Develop strategy for water rights acquisition.
- Continue legislative advocacy.
- Explore alternative medical waste processing options.
