2. APPROVE OCTOBER 9, 2024, MCPSCC MEETING MINUTES

MOTION: A motion was made to approve October 9, 2024, MCPSCC meeting minutes. Seconded. Motion passed unanimously.

4. HB4002 UPDATE

-Sheriff Nick Hunter, District Attorney Paige Clarkson, and Ryan Matthews *Summary of presentation:*

- Implementation of HB4002 includes the expansion of the Law Enforcement Assisted Diversion (LEAD) program, the new deflection hotline, and the progress of the Restore Court:
 - Certified Recovery Mentors handle referrals 24/7.
- Restore Court addresses drug and other related crimes:
 - Success in court expunging charges.
 - The court has had 11 referrals enrolled into services:
 - There was a total of 13 referrals.

- 12 are actively engaged in treatment.
- Has had a slow start but numbers are growing.
- Law enforcement report increased ability to search vehicles and seize guns under HB4002, leading to improved public safety.
- Ongoing training for deputies on drug investigations.
- Marion County is collaborating with other jurisdictions:
 - Other counties are implementing similar models to Marion County's model.
- Work crew is helping generate revenue for restitution.

5. STABILIZATION CENTER UPDATE

-Commander Mike Hartford

Summary of presentation:

- The Transition Center closed, and the new Stabilization Center's purpose were discussed.
- New Case Management Model:
 - The goal is to make it less institutional and more focused on preparing individuals for successful re-entry into the community.
 - Includes services addressing substance abuse, mental health, and other needs.
- Hiring new Stabilization Specialists:
 - Will get extensive training in core correctional practices and case management techniques to better support the individuals housed at the center.
- Purchased a retina drug scanning device.
- Expanded the stabilization mentor program.

6. OREGON DISTRICT ATTORNEYS' ASSOCIATION (ODAA) PROACTIVE LEGISLATIVE AGENDA

Summary of presentation:

- -District Attorney Paige Clarkson
 - It is important to educate legislators on the nuances of expungement:
 - Specifically, regarding domestic violence and sexual assault crimes.
 - There have been legislative efforts to all for automatic expungement of certain crimes:
 - Concerns on automatic expungement of domestic violence and sexual assault.
 - Many criminal statutes are based on predicate offenses and repeat offenses can lead to more serious charges:
 - Automatic expungement of certain crimes can undercut the foundation of predicate offense statutes.
 - Legislators with no public safety background are unaware of nuances and implications of automatic expungement.
 - The ODAA's aims to provide expertise to inform the legislative process.
 - ODAA has been doing outreach to all legislators.

MOTION: A motion was made to approve the reallocation of \$206,813 from the Justice Reinvestment Program to fund the expanded stabilization mentor program. Seconded and passed unanimously.

7. CRIMINAL JUSTICE ADVISORY COUNCIL (CJAC)

Summary of presentation:

- The Oregon Public Defense Commission (OPDC) requested to review the county's crisis plan:
 - Marion County was the only county that agreed to meet to review the plan.
 - It was found that Marion County implemented everything outlined in the plan:
 - OPDC did not follow through on their outlined plan commitments.
 - Marion County has been providing counsel to all in-custody individuals:
 - OPDC's, Trial Division lawyers, only handle in-custody cases.
 - They do not take on Marion County's cases, as they have for other counties.
 - OPDC agreed to take on additional cases from Marion County, including probation violations (PVs), DUIs, and diversions.
- This will help with some of the burden on Marion County's contract lawyers.
- The main issue is the maximum attorney capacity set by OPDC:
 - Limits the number of cases lawyers can handle per year.
- The cap and monthly limit on case points creates challenges in fully utilizing Marion County's public defenders.

8. JUSTICE REINVESTMENT GRANT UPDATE

Summary of presentation:

- The Justice Reinvestment Grant funds 10 programs in Marion County:
 - 8 are administered by the Sheriff's Office.
 - 2 are victim service provider funding and the specialty court program:
 - Administered by other agencies.
- Required quarterly reporting to the Criminal Justice Commission on people served and financial spending on the programs.
- Updates to the Marion County Public Safety Coordinating Council are part of the oversight and reporting process for the grant-funded programs.
- Program Highlights:
 - Prison Diversion (Senate Bill 416) has steady service with a decline in recent quarters:
 - Motivation classes have helped boost engagement.
 - Transition From Jail to Community has declined in referrals and completion rates due to the Transition Center closure:
 - Expect improvements with the new Stabilization Center.
 - Link-Up for dual diagnosis individuals has stable service levels but declining completion rates:
 - Need retention strategy enhancements.
 - Student Opportunity for Achieving Results (SOAR) had significant growth in enrollment:
 - The new female cohort has graduation rates around 55-60%.
 - The De Muniz Resource Center saw a sharp decline in service delivery after the closure of the Transition Center, and the remaining funds were reallocated

to the new stabilization mentor program.

- The housing program provided 120 temporary housing stipends in the last two quarters to 71 different recipients.
- The Corrections Treatment with Bridgeway showed improvement in completion rates.
- Peer Support, Resiliency, and Recovery saw a peak in participation, with higher completion rates in the last two quarters.
- The Justice Reinvestment Grant Update will be a standing agenda item for future meetings to ensure ongoing reporting and oversight of these important community programs.

10. OPEN DISCUSSION 2025 GOALS & PROJECTS

Summary of presentation:

- Address youth crime and violence in the community:
 - Concerning trends in juvenile crime and violence in the community.
- Map out existing resources for youth to identify gaps, and better coordinate efforts across different organizations.
- The System of Care, a community group serving children, youth, and families, a potential partner to align prevention efforts:
 - Include youth voices in their strategic planning process.
- Need to balance accountability and support among the youth.
- Focus on parental accountability to improve outcomes.
- Complex issues need collaborative, community-wide effort to address youth crime and violence:
 - Involve a wider range of stakeholders, including faith-based organizations, community groups, and the creative community.
- Need to have opportunities for youth to engage in.
