#### Approve July 9, 2024, MCPSCC Meeting Minutes

**MOTION:** A motion was made and seconded to approve the July 9, 2024, MCPSCC meeting minutes. Motion passed unanimously.

#### **2. HB4002 UPDATE**

-Sheriff Nick Hunter, District Attorney Paige Clarkson, and Ryan Matthews *Summary of presentation:* 

- HB4002 made small amounts of drugs illegal again in Oregon;
- LEAD program in Marion County is a pre-existing initiative to handle drug-related issues.
- Expansion of the Law Enforcement Assisted Diversion (LEAD) program and its funding through the county.
- Restore court docket for individuals with less than \$5,000 in restitution, allowing them to work off their debt through community service.
- Interest in Marion County's approach from other counties and law enforcement agencies.
- Need for resources and immediate engagement with individuals to ensure treatment.
- Misconceptions in the public and law enforcement about the new law and the process.
- Health services' readiness to handle deflection referrals, including the establishment of a 24/7 hotline and the success of the Restore court docket:
  - One referral leading to active engagement in treatment.
- Challenge of pulling cases from the unrepresented list and need direct referrals for better

success rates.

- Challenges include lack of accountability and the strain on criminal defense lawyers.
- The public defender crisis is attributed to the decision of defenders reducing caseloads, creating a resource problem.
- Lack of dedicated funds for juvenile services.
- Need for behavioral change and the role of lived experience in the LEAD program.
- Important to measure success in terms of houselessness, gainful employment, drug use reduction, and recidivism.

### **3. TRANSITION CENTER RE-PURPOSING**

- Closure of the Transition Center and plan to repurpose it as the Stabilization Center.
- The focus on treatment, case management, and victim restitution was highlighted.
- Need new staffing models and hiring challenges discussed.
- Importance of stability and the role of the stabilization center in providing treatment and case management.
- Plan to reopen the stabilization center within a year, with a focus on victim restitution and treatment.
