 **County and City Candidates:** Candidates for county and city those offices, unless otherwise provided for by charter or ordinance, are elected at the primary or general election. If a county or city charter provides for candidates to be elected at an election other than the primary or general election but does not specify a deadline or adopts the statutory filing deadline, ORS 249.722 applies.

 **District Candidates:** The enabling statutes, or principle act, of a district specifies how board members are elected. Most districts, as defined in ORS 255.012, elect board members at the regular district election which is held in May of odd numbered years or at the Primary or General Election. As provided for in ORS 255.235(2)(a), the March and September deadlines included above are only applicable if the election is a district's first election to elect board member and are not included in the daily calendar.

 For resubmitted measures the deadline is 47th day before the election; the measure argument filing deadline is 2nd business day after deadline to resubmit measure, if the county includes the resubmitted measure in the county voters' pamphlet.
