City of Mill City Measure 22-188

Should Marijuana be Sold and Processed in Mill City?

Question: Shall Mill City allow medical and recreational marijuana dispensaries; producers, processors, wholesalers and retailers?

Summary: In 2016 the voters in Mill City prohibited the sale and processing of both medical and recreational marijuana. If this initiative is approved it would allow the sale and processing of medical and recreational marijuana.

Approval of this initiative would allow the sale of both medical and recreational marijuana subject to restrictions that are currently set forth in state statutes and Mill City Ordinance No. 384 which is codified in Title 17 of the Mill City code. Approval of this initiative would also allow the processing of medical and recreational marijuana; again subject to restrictions currently in place.

If this measure is approved the city of Mill City would become eligible for tax revenues generated by the sale of medical and recreational marijuana including state marijuana tax revenues and local tax revenues.

Stayton Rural Fire Protection District Measure 24-459

Five-Year Local Option Tax for General Operations

Question: Shall the District impose \$0.8885 per \$1,000.00 of assessed value for general operations for five years beginning 2022-2023? This measure may cause property taxes to increase more than three percent.

Summary: If approved, this measure would provide funds to Stayton Rural Fire Protection District to increase staffing levels by adding nine new full time firefighters and emergency medical technicians.

The proposed rate is estimated to raise approximately \$900,000.00 in 2022-2023, \$927,000.00 in 2023-2024, \$979,937.00 in 2024-2025, \$1,009,335.00 in 2025-2026 and \$1,039,615.00 in 2026-2027, for a total of \$4,855,887.00 over five years. The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of the estimate and may reflect the impact of early payment discounts, compression and the collection rate.

Measure 24-459 Explanatory Statement

Stayton Fire District responds to over 1,100 annually (averaging over 3 calls a day) providing structural and wildfire firefighting, rescue, hazardous materials, motor vehicle accidents and emergency medical calls for service to the communities of Elkhorn, Marion, Mehama, Mt. Pleasant, City of Stayton and 13 miles of Hwy 22; totaling 107 square miles in Marion and Linn counties combined.

How would the money be used?

If approved this would provide enough revenue to fund nine full-time firefighter positions, 3 positions per 24-hour shift, to improve response times 24/7. These positions would assist our current 5 paid firefighters who work 8 to 5, Monday thru Friday performing functional duties for the district and response to emergency calls and our dedicated volunteer responders who respond after hours and on weekends.

Why is there a need?

The fire district is experiencing an increase in calls for service and a decline in volunteers. The importance of a timely response to fires and medicals can make a difference. Volunteers respond from their homes which takes on average 7 minutes to get to the station before responding on an emergency vehicle. With staff at the fire station that response time is greatly reduced for emergency personnel to arrive at a call. There are times we have limited or no response during the weeknights and weekends from our volunteers. Our volunteers will continue to respond to provide additional resources.

The district is not part of, nor does it receive funding from any city, county, or state government. It is a separate taxing "Special District".

The district is funded through a permanent property tax base rate of \$1.33 per thousand assessed value that was created in 1997 by the state. The tax revenue has not kept up with cost increase or the demand for services.

What is the cost to property taxpayers?

This 5-year levy would have a fixed rate of \$.8885 cents per thousand for five years. This means for a house with an assessed value of \$250,000, it would cost the average homeowner \$222.13 per year or \$18.51 per month.

What if the Levy is not approved?

With the increase in calls for service and limited number of volunteers, our ability to provide reliable, effective, and efficient service will not be able to meet the increasing emergency service demand and response times for our citizens. We will continue efforts to recruit additional volunteers in a time when volunteering is on the decline.



Use a black or blue ink pen to completely fill in the box to the left of your choice.


To Correct a Mistake:

WHAT IF I...?

What if I change my mind after I turn in my ballot?

Your ballot has been cast as soon as you deposit it in the mail or at a drop site. After that, you cannot receive a new ballot.

What if I don't vote on everything on the ballot?

Your ballot will be counted.

What if I don't sign my Return Envelope?

We will attempt to contact you, letting you know that your Return Envelope was not signed.
