No later than the **81<sup>st</sup> day before an election**, a governing body that has referred a measure must prepare and file with the local elections official the text of the referral for ballot title preparation or the ballot title for publication of notice of receipt of ballot title. This form may be used to file the text of the referral and request the elections official begin the ballot title drafting process or file a ballot title and request the elections official publish notice of receipt of ballot title.

<p><b>Caption</b> 10 words which reasonably identifies the subject of the measure. Five-year operations levy for fire and emergency medical services.</p>															
<p><b>Question</b> 20 words which plainly phrases the chief purpose of the measure. Shall the District levy \$0.44 per thousand of taxable assessed value for 5 years, beginning Fiscal Year 2025-26 for operations? This measure may cause property taxes to increase more than three percent.</p>															
<p><b>Summary</b> 175 words which concisely and impartially summarizes the measure and its major effect.</p> <p>This measure, if approved, would authorize the District to levy taxes to support the annual cost of fire and emergency medical services. The measure would provide for a local option operating levy at a rate not to exceed \$0.44 per \$1000 of taxable assessed value within the District for five years, beginning July 1, 2025. Revenue from the levy would be used to fund general operations, replacement of and maintaining aging equipment, capital construction and improvements to public safety facilities, and replenish District reserves.
