Final Ballot Title The following is the final ballot title of the measure to be submitted to the city's voters. The ballot title notice has been published and the ballot title challenge process has been completed.

Shall Hubbard establish a motor vehicle fuel tax of \$0.03 per gallon on motor vehicle fuel dealers?

Summary 175 words which concisely and impartially summarizes the measure and its major effect.

This measure would impose a \$0.03 per gallon tax on all motor vehicle fuel sold, used, or distributed within the City. The tax will be paid on a monthly basis by motor vehicle fuel dealers. Revenue from the tax would only be used for the construction, reconstruction, improvement, repair, maintenance, operation, and use of public highways, roads, and streets in the City and those subject to City control.

A "Yes" vote would approve a \$0.03 per gallon tax on motor vehicle fuel sold, used, and distributed within the City, requiring fuel dealers to pay the tax to the City on a monthly basis.

A "No" vote would reject the \$0.03 per gallon tax on motor vehicle fuel sold, used, and distributed within the City.

Projects that could be potentially funded by the tax include:

Sidewalk and road improvements. The first project identified is to complete the sidewalk along 3rd Street from "A" Street to Moon Beam.

Under State law any increases to such taxes must be approved by the voters.
