### Welcome and Introductions

## HOPE ALIVE

### **East Salem Project**

Shaney explained that the CFC Steering Committee discussed at their most recent meeting about how the commission can wrap around the project that the Boys and Girls Club is working on. Shaney mentioned that this project is not just for the Boys and Girls Club but that it is for our community and the families in this area. The needs of the community surrounding the project area align with many organizations in the commission if not all. Data collection has already started for this area; however, collecting more data from all the organizations at the table about how they interact with the same neighborhood and really understanding what these neighborhoods need, it could really help create the framework for a project that infuses hope and the Outward Mindset. Because this will be a long term project, there is opportunity to do other work that parallels this project.

Sue gave a short background of their project. The Epping family plans to gift the property to the Boys and Girls Club, which is located across from Winema Campus the first of 2020. In September 2018, Mid Valley Council of Governments completed a needs assessment for Boys and Girls Club that looked at challenges within the schools, such as high density youth populations, attendance, and low performing schools. That assessment was then overlaid with available after school services. What this showed were high need, large student populations, and not a lot after school programs throughout the Salem Keizer area. Within the one mile radius of the Epping property, there are nearly 3,700 school-age youth. The intent is to build a 25,000 square foot facility that would service first graders through seniors in high school. This facility would also include a space for a law enforcement officer to complete their paperwork and spend time with the kids. This is aimed to demonstrate law enforcement as partners, advocates, and supporters of safe and happy environments.

### **Neighborhood Project and Data**

At the Steering Committee meeting on September 12<sup>th</sup>, the committee brainstormed about what data their individual organizations could start to compile that might assist in moving the project forward. Individuals shared their thoughts from that meeting and discussions ensued. It was stressed that while the Boys & Girls Club was the catalyst for the discussion within the Steering Committee, this is not about the Boys & Girls Club. This project is about the community and what the needs are.

The key points collected during the discussion can be found at the end of the meeting summary notes.

- **Who is missing from the table?**
- **What do we want to measure?**
- **What do we want to see as a result of this project?**

### **Mountain West Video – Breaking through Barriers to Graduation: McKay High School changes student’s lives**
