The Mid-Willamette Valley Council of Government (MWVCOG) enthusiastically supports grant applications from Internet Service Providers (ISPs) operating in Marion County to secure funds through the Broadband, Access, Equity, Deployment (BEAD) Program. This grant would enable ISPs to deploy high-speed broadband infrastructure to serve rural residences and businesses that currently do not have access to internet in the Silver Falls School District, the principal focus of the BEAD program.

The MWVCOG is the Federally designated Economic Development District serving Marion, Polk and Yamhill Counties. Part of our mission is to coordinate regional planning and development activities for our members, including enhancing access to critical services, such as broadband, to rural areas in the region. In 2023, MWVCOG staff helped establish the Mid-Willamette Valley Broadband Action Team, which includes representatives from Marion, Polk, and Yamhill Counties, to promote the development of broadband infrastructure in areas currently lacking internet access.

Access to high-speed broadband internet is essential in ensuring the residences, businesses and communities of Marion County have access to the critical services they need to live healthy and successful lives. Large areas of the Silver Falls School District, especially rural areas, struggle with substandard broadband connectivity or no connection at all – inhibiting the ability to fully engage in online services such as education, healthcare, remote work and e-commerce. The 2020 Labor Day fires highlighted the critical importance of broadband access to public safety, emergency management response, and communication infrastructure resilience.

I encourage the Oregon Broadband Office to support this BEAD grant application to help Marion County ISPs bridge the digital divide, enhance economic growth and ensure the residences, businesses and communities of the Silver Falls School District have equitable access to reliable and affordable high-speed broadband internet.


