Presentation:

- **Marion County Correction Re-Entry Program**
 - See PowerPoint
 - Working to prevent recidivism
 - Recidivism: committing another criminal offense within a three year period
 - Tracking the percentage of recidivism over time
 - Everyone will be safer/stronger
 - Ten years ago, Marion County had a recidivism rate of 40%- the highest rate in the state of Oregon
 - Reducing Risk/Enhancing Responsively
 - Identify the risk factors and create an individualized plan
 - Find out what their motivation to make a change is

- What is the chance of the individual to recidivate?
- A collaborative effort
 - Reaching out to experts in the community to aide in workforce training and education
 - We have local elected leaders that are very supportive of this populations and realize this is a community issue
- Evidence Based
 - Motivation, which can be assessed, is significant to the prevention of recidivism
 - Hold cognitive and motivation classes to. After the individual has completed the class, referrals to drug and alcohol treatment programs can be made
 - The classes assist them to begin thinking cognitively (“I can see how this has negatively affected me”)
 - Do not overly supervisor the low risk population
 - Don’t treat them as if they are a high risk this will cause them to become a higher risk
- High Priorities
 - Focus our time and energy with referrals to the experts
 - See what can be done to receive funds
 - Looking to treat not just the substance abuse, but the addiction linked to criminality in an evidence based manner
 - People with mental health or co-occurring issues has become a priority over the last two years
 - Working to get them services when they get out of prison
- Reach Ins
 - People released from prison wouldn’t show up for community corrections intake
 - With Reach-In, no show rate went from 30% to 2%
 - Began workshops letting inmates know what to expect to go through upon release
 - Mentoring
 - Try to link with volunteer and profession mentor while in prison. When they get out they have a solid positive support system
 - Housing
 - Cognitive Classes
- SOAR
 - Allows Marion County to offer cognitive, comprehensive, all-inclusive program, rather than target a specific conviction type
 - Employment-working with employers to not allow a conviction to be the only reason for denial
 - Job growers, De Muniz Resource

- Community Breakfasts- the community comes together in support of MCRI

Presentation:

- **Veteran Center at Western Oregon University**
 - Bunker Project
 - An off campus drop-in center that formed a support network for veterans
 - The project fell through, however, WOU is picking it up
 - Kyle Rodgers is going to be the Director of the Program, 714-673-7356 (cell)
 - Projected opening date of January 1, 2014
 - Program could benefit from community support
 - Focuses
 - Substance abuse and PTSD go hand in hand
 - Suicide prevention
 - Getting men off the street and into school
 - Walk veterans through the enrollment process
 - Prevent incarceration
 - Program will be located on Western Oregon University's campus near student affairs
 - Kyle Rodgers is to bring back more information when the program is more concrete.
