## <u>Presentation:</u> Dementia and Addiction – presented by Ann McQueen PhD (handout)

- > Presentation and discussion continued from last meeting
- > Dementia can facilitate addictive behavior in many ways
  - Caregivers can also have depression and self mediacte, as they are sometimes reluctant to let others assist or take a break.
- ➤ There is a form of Dementia related to alcohol addiction called Korsakoff syndrome.
- ➤ There are some assessment tools available such as the Saint Louis University Mental Status Examination (SLUMS) and the Montreal Cognitive Assessment (MOCA) which can assist health professionals in detecting cognitive impairment, which may be due to medication or disease.
