Presentation/Update: Status of Mid-Valley Opioid Safety Group Grant (handout)

Sub-committee met to brainstorm ideas for grant money and came up with idea of holding a series of conferences (3) with the theme of Pregnancy and Opiates.

1st conference – focus on immediate and urgent need for action

2nd conference – focus on prevention

3rd conference – focus on long term care

Committee discussed idea around conferences and thought it might be better and more cost effective to hold only one conference with a key note speaker, or several speakers, where attendees then split of into separate groups/areas of interest. Sub-committee/steering committee needed to work on project outside of regular LADPC meetings. Sub-committee members will include Ray, Daryl, Wendy, Teri Morgan, Jill Dale, Kerryann and Audra from NOWS, if available.

Need further discussion around venue, gaps in services, key focus, who to invite and potential date. May want to invite someone from the State as it may prove valuable for future projects and grant monies, treatment providers and some from medical community. Ray will contact Audra from “NOWS” for additional data.

Dr Coelho – early life intervention crucial age 0–3, as this is critical in determining future outcomes/social determinants.
