# October 5, 2017 Meeting Minutes

<u>Call to order & Introductions</u> – Chair, Ray Wilson called meeting to order at 8:09am; introductions followed.

## **Approval of Meeting Minutes:** (handout)

# **Review/Discussion:** New member application (handout)

Strategic planning conversations taking place within Health Department and stakeholder interviews will be conducted. Cary would like LADPC's involvement at some level.

Committee discussed finding a topic to focus on, gathering and updating data and formally presenting to the Board. Committee will review data at next meeting, which will include White Paper.

### **Update:** CCTV Programming:

Ray attended orientation and would like to see an ongoing segment highlighting various drug and alcohol issues, as this would be a good outlet for education and prevention. Committee would need to operate all equipment.

Cary – Board of Commissioners have a newsletter where divisions within the Health Department are interviewed and highlighted. May be able to have them include a segment on LADPC.
